

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Robin Selati DOCKET NO.: 09-33162.001-R-1 PARCEL NO.: 05-18-401-029-0000

The parties of record before the Property Tax Appeal Board are Robin Selati, the appellant, by attorney Richard Shapiro in Evanston, and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$42,323
IMPR.:	\$137,128
TOTAL:	\$179,451

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2009 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of masonry construction with 3,994 square feet of living area. The dwelling is approximately 63 years old. Features of the home include a full basement, central air conditioning and two

fireplaces. The property has a 38,476 square foot site and is located in Winnetka, New Trier Township, Cook County. The subject is classified as a class 2-06 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on six equity comparables.¹

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$179,451. The subject property has an improvement assessment of \$137,128 or \$34.33 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on two equity comparables.

In rebuttal, the appellant's attorney stated that only one of the board of review comparables were located in the same block as the subject, compared to three of the appellant's comparables.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment the subject property. 86 Ill.Admin.Code comparables to §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

Both parties presented information on a total of eight suggested comparables. The Board finds the best evidence of assessment equity to be the appellant's comparables #2 and #4 and board of review comparable #2. These comparables were located in the same block as the subject. Additionally, board of review

¹ The appellant completed Section V of the residential appeal form with information on four comparables. The appellant did not provide the age of comparable #1. The appellant also provided a spreadsheet with two additional comparables; however, descriptive information about the additional properties was not provided.

comparable #2 was most similar to the subject in living area, and the appellant's comparables #2 and #4 were most similar in age. These comparables had improvement assessments that ranged from \$21.31 to \$39.82 per square foot of living area. The subject's improvement assessment of \$34.33 per square foot of living area falls within the range established by the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified. This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
