

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Rajinder Sachdeva DOCKET NO.: 09-33174.001-R-1 PARCEL NO.: 07-34-104-030-0000

The parties of record before the Property Tax Appeal Board are Rajinder Sachdeva, the appellant(s), by attorney Thomas J. Thorson, of Raila & Associates, P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$ 7,980
IMPR.:	\$ 41,415
TOTAL:	\$ 49,395

Subject only to the State multiplier as applicable.

# Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2009 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

# Findings of Fact

The subject property consists of a two-story dwelling of masonry construction with 4,305 square feet of living area. The dwelling is 12 years old. Features of the home include a full

basement, central air conditioning, one fireplace and a threecar garage. The property has a 19,950 square foot site and is located in Schaumburg Township, Cook County. The property is a class 2-08 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted an appraisal estimating the subject property had a market value of \$555,000 as of March 12, 2010. Further, in support of this argument the appellant submitted conflicting evidence disclosing the subject property was purchased on March 22, 2010 for a price of \$555,000 and that it sold in 2009 for a price of \$550,000. Based on this evidence, the appellant requested a reduction in the subject's assessment to reflect the purchase price

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$71,802. The subject's assessment reflects a market value of \$806,764 or \$187.40 per square foot of living area, including land, when applying the 2009 three year median level of assessments for class 2 property of 8.90% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted four equity comparables with sales information on the subject's 2006 sale.

## Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist appraisal of the subject property, a recent of an sale, 86 Ill.Admin.Code comparable sales or construction costs. §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of market value to be the appraisal submitted by the appellant. The subject's assessment reflects a market value above the best evidence of market value in the record. The Board finds the subject property had a market value of \$555,000 as of the assessment date at issue. Since market value has been established the 2009 three year median level of assessment for class 2 property of 8.90% as determined by the Illinois Department of Revenue shall apply. (86 Ill.Admin.Code §1910.50(c)(2)).

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:
