

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Rafel Ramos

The parties of record before the Property Tax Appeal Board are Rafel Ramos, the appellant(s), by attorney Adam E. Bossov, of Law Offices of Adam E. Bossov, P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$4,000 **IMPR.:** \$667 **TOTAL:** \$4,667

Subject only to the State multiplier as applicable.

## Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2010 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

### Findings of Fact

The subject property consists of 5,000 square foot parcel of land improved with a 55-year old, one-story, frame, single-family dwelling containing 1,031 square feet of living area. The property is located in Evanston Township, Cook County. The subject is classified as a 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant's appeal is based on inequity and overvaluation. In support of the overvaluation argument the appellant submitted evidence disclosing the subject property was purchased in May

2010 for a price of \$52,200. The appellant included a copy of the multiple listing service database printout listing information on the sale of the subject. In addition, the appellant included sales information on eight suggested comparables.

In support of the inequity argument, the appellant submitted six suggested comparables. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$18,211 with an improvement assessment of \$13,836 or \$13.42 per square foot of living area. The subject's assessment reflects a market value of \$154,765 using the Illinois Department of Revenue's three-year median level of assessment for class 2, residential property of 8.94% for tax year 2010.

In support of its contention of the correct assessment, the board of review submitted four equity comparables.

At hearing, the appellant's attorney argued that the appellant's equity comparables support a reduction in the subject's assessment. He acknowledged the sale of the subject was a distressed sale, but argued that the sale comparables support this sale as being at the bottom of the market range. The appellant argued that a previous Property Tax Appeal Board appeal, 08-30073.001-R-1, supports a reduction based on a distressed sale that is at market.

The board of review's representative, Lester McCarroll, argued that the subject's sale was a short sale and, therefore, not reflective of the market. He argued that six of the eight sales comparables sold for prices above the subject's purchase price.

Under cross examination, Mr. McCarroll acknowledged that the appellant's comparables are located within the same neighborhood code as the subject.

# Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds that the mere assertion by the board of review that the subject's sale was not at market solely because it is a compulsory sale is accorded no weight without evidence supporting that assertion. The Board finds the board of review failed to

provide any evidence either to challenge the arm's length nature of the transaction or to refute the contention that the purchase price was reflective of the market. The board of review merely argued that the sale was not at market because it was a compulsory sale which is a sale under duress.

The Board finds the best evidence of market value to be the purchase of the subject property in May 2010 for a price of \$52,200. The appellant provided evidence demonstrating the sale was at the low end of the market. Therefore, the Board finds the subject had a market value of \$52,200. Since the market value of this parcel has been established, the 2010 Illinois Department of Revenue three-year median level of assessment for Class 2 property of 8.94% will apply and a reduction is warranted. The Board finds the appellant is equitably assessed.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
