

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Ahmed Shaaban, the appellant(s), by attorney Joseph G. Kusper, of Storino Ramello & Durkin in Rosemont; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

### Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2010 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

## Findings of Fact

The subject property consists of two vacant land parcels totaling 8,150 square feet. The property is located in Hyde Park Township, Cook County. The property is a class 1-90, other

minor improvements which does not add value, property under the Cook County Real Property Assessment Classification Ordinance.

The appellant argued there was unequal treatment in the assessment process of the land as the basis of this appeal. In support of the equity argument, the appellant submitted assessment information on a total of four properties suggested as comparable. These parcels range in size from 4,075 to 11,410 square feet and have assessments from \$1.02 to \$1.12 per square foot. The properties are classified as 5-17, one story store; 5-90, commercial minor improvements; and 3-15 two or three story non-fireproof corridor apartments or California type apartments, interior entrance. The assessment information for comparables #3 and #4 are listed as partial assessments.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$13,447 and a land assessment of \$13,040 or \$1.60 per square foot. In support of its contention of the correct assessment the board of review submitted 10 sales comparables.

# Conclusion of Law

The appellant contends unequal treatment in the subject's assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not met this burden.

The Board finds the appellant's suggested comparables are not similar to the subject. These properties are improved; have different levels of assessment; and/or have a classification as commercial or an apartment. The appellant failed to submit complete information on suggested comparables #3 and #4. Therefore, the Board finds the appellant failed to show by clear and convincing evidence that the subject is over assessed when compared to similar properties and no reduction is justified.

#### IMPORTANT NOTICE

Docket No: 10-25649.001-I-1 through 10-25649.002-I-1

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
