

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Si Wu DOCKET NO.: 10-28000.001-R-1 PARCEL NO.: 10-22-302-044-0000

The parties of record before the Property Tax Appeal Board are Si Wu, the appellant, by attorney Stephanie Park of Park & Longstreet, P.C. in Rolling Meadows; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$4,134
IMPR.:	\$18,936
TOTAL:	\$23,070

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2010 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

Docket No: 10-28000.001-R-1

The subject property consists of a 1.5-story dwelling of frame and masonry construction with 1,052 square feet¹ of living area. The dwelling is 54 years old. Features of the home include a partial basement finished with a recreation room and a 2-car detached garage. The property has a 5,011 square foot site and is located in Skokie, Niles Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on eight equity comparables.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$26,240. The subject property has an improvement assessment of \$22,106 or \$14.00 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four equity comparables.

The appellant's attorney submitted a rebuttal brief in response to the board of review's evidence.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment the subject property. comparables to 86 Ill.Admin.Code The Board finds the appellant met this burden of §1910.65(b). proof and a reduction in the subject's assessment is warranted.

The Board finds appellant's comparable #3 and #6 to be the best comparables in the record based on design. More weight was given to comparable #6 due to the similarity when compared to the subject property. These two comparables have an improvement assessment of \$17.41 and \$18.18 per square foot of living area. The subject's improvement assessment of \$21.01 per square foot

 $^{^1}$ The board of review has the subject property listed as 1,579 square feet of living area. The appellant argued the building size was actually 1,052 square feet of living area.

of living area is above the amount established by the best comparables in this record. Less weight was given to the board of review comparables due to the dissimilar amount of living area when compared to the subject property. Based on this record the Board finds the appellant demonstrated with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is justified. This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

Docket No: 10-28000.001-R-1

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
