

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Young S. Park DOCKET NO.: 10-33068.001-R-1 PARCEL NO.: 03-19-215-025-0000

The parties of record before the Property Tax Appeal Board are Young S. Park, the appellant, by attorney Stephanie Park of Park & Longstreet, P.C. in Rolling Meadows; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$4,070
IMPR.:	\$18,360
TOTAL:	\$22,430

Subject only to the State multiplier as applicable.

## Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2010 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

# Findings of Fact

The subject property consists of a one-story dwelling with frame and masonry construction. The dwelling is approximately 50 years old and has 1,459 square feet of living area. Features of the home include a crawl-space foundation, central air Docket No: 10-33068.001-R-1

conditioning, a fireplace and a two and one-half car garage. The property has a 9,045 square foot site and is located in Arlington Heights, Wheeling Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation and assessment inequity as the bases of the appeal. In support of the overvaluation argument, the appellant submitted eight comparable sales. These comparables sold from June 2009 to December 2010 for prices that ranged from \$140,000 to \$275,000 or from \$124.07 to \$157.50 per square foot of living area, land included. In support of the inequity argument, the appellant submitted information on eight equity comparables. Based on the evidence submitted, the appellant requested that the subject's total assessment be reduced to \$18,200.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$23,971. The subject's assessment reflects a market value of \$239,710 or \$164.30 per square foot of living area, including land, when using the 10% ordinance level of assessment for Class 2 residential property in Cook County.

In support of its contention of the correct assessment, the board of review submitted information on four comparable sales. These comparables sold from October 2008 to May 2010 for prices that ranged from \$242,000 to \$300,000 or from \$206.19 to \$272.99 per square foot of living area, land included.

The appellant's attorney submitted a rebuttal brief.

## Conclusion of Law

The appellant contends in part the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment based on overvaluation is warranted. The Board finds the best evidence of market value to be the #1, #6, appellant's comparable sales #7 and #8. These to the subject comparables were similar in almost all characteristics and sold from June 2009 to December 2010 for prices ranging from \$124.07 to \$157.50 per square foot of living area, including land. The subject's assessment reflects a market value of \$164.30 per square foot of living area, including land, which is above the range established by the best comparable sales in this record. Based on this evidence, the Board finds a reduction in the subject's assessment based on overvaluation is justified.

Based on the reduction granted due to the market value finding, the Board finds a further reduction in the subject's assessment based on assessment inequity is not warranted. This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

Docket No: 10-33068.001-R-1

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
