

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Gerrard Inguagiato DOCKET NO.: 10-33498.001-R-1 PARCEL NO.: 04-36-105-003-0000

The parties of record before the Property Tax Appeal Board are Gerrard Inguagiato, the appellant, by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 8,652 **IMPR.:** \$ 38,723 **TOTAL:** \$ 47,375

Subject only to the State multiplier as applicable.

<u>ANALYSIS</u>

The subject property is improved with a multi-level dwelling of frame and masonry construction containing 1,415 square feet of living area. The dwelling is 49 years old. Features of the home include a partial, finished basement and a one-car garage.

The appellant's appeal is based on unequal treatment in the assessment process regarding the subject's improvement. The appellant submitted limited information on five comparable properties with varying degrees of similarity to the subject. The comparables have improvement assessments ranging from \$22.08 to \$23.78 per square foot of living area. The subject's improvement assessment is \$27.37 per square foot of living area.

Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed. The board of review presented descriptions and assessment information on four comparable properties with varying degrees of similarity to the subject. These properties have improvement assessments ranging from \$24.81 to \$27.72 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is not warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not met this burden.

The Board finds the comparables submitted by both parties were generally similar to the subject in location/size/style/exterior construction/features and/or age. The comparables had improvement assessments that ranged from \$22.08 to \$27.72 per square foot of living area. The subject's improvement assessment of \$27.37 per square foot of living area is within the range established by the comparables in this record. Slightly less weight was given the appellant's comparables #1 and #2 based on their dissimilar size when compared to the subject. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's improvement assessment is equitable and a reduction in the subject's assessment is not warranted.

IMPORTANT NOTICE

Docket No: 10-33498.001-R-1

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
