

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Matthew Hulsizer, the appellant(s), by attorney Glenn S. Guttman, of Rieff Schramm Kanter & Guttman in Chicago; the Cook County Board of Review; the New Trier Twp. H.S.D. #203 intervenor, by attorney Scott L. Ginsburg of Robbins Schwartz Nicholas Lifton Taylor in Chicago.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$180,652 **IMPR.:** \$566,559 **TOTAL:** \$747,211

Subject only to the State multiplier as applicable.

# **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2013 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story, single-family dwelling of masonry construction with 10,791 square feet of living area. The dwelling was constructed in 1995. Features of the home include a partial finished basement, six and two-half baths, air conditioning, four fireplaces, and a three-car garage. The property has a 89,211 square foot site and is located in Winnetka, New Trier Township, Cook County.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables. The appellant requested a total assessment reduction to \$486.901

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$747,211. The subject property has an improvement assessment of

\$566,559 or \$52.50 per square foot of living area. In support of the assessment, the board of review submitted three equity comparables.

The intervenor, New Trier High School District #203 submitted information on seven equity comparables.

In rebuttal, the intervenors argued that the comparables submitted by the appellant should be given diminished weight because they were dissimilar to the subject in various key property characteristics. The intervenor reaffirmed the request that the subject's assessment not be reduced.

### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be the intervenors comparables #3, #4, and #5 and the board of review's comparable #2. These comparables had improvement assessments that ranged from \$51.78 to \$75.13 per square foot of living area. The subject's improvement assessment of \$52.50 per square foot of living area falls within the range established by the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
