

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Keith T. Clayton, the appellant, by attorney Arnold G. Siegel, of Siegel & Callahan, P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 7,310 **IMPR.:** \$ 17,839 **TOTAL:** \$ 25,149

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2011 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 100-year old, one and one-half story, single-family dwelling with 1,863 square feet of living area of masonry construction. Features of this vacant, unoccupied home include a full basement, one fireplace and a one-car garage. The property has an 8,600 square foot site and is located in Oak Park Township. The subject is classified as a class 2, residential property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted an appraisal estimating the subject property had a market value of \$265,000

as of January 1, 2011. The appraisal stated that the subject was vacant and unoccupied. The appellant requested application of the Illinois Department of Revenue's three year median level of assessment of 9.49%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$38,795. The subject's assessment reflects a market value of \$408,799 when applying the 2011 three year average median level of assessment for class 2 property of 9.49% as determined by the Illinois Department of Revenue. As to the subject, the subject's property characteristic printout reflects the absence of a homeowner's exemption in tax years 2010 and 2011. Moreover, the appellant/taxpayer's address is listed as 1321 Maple Avenue in Wilmette, while the subject's address is 316 Elmwood in Oak Park.

In support of its contention of the correct assessment, the board of review submitted descriptive, assessment and sales information on four suggested comparables.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant *met* this burden of proof and a reduction in the subject's assessment *is* warranted.

The Board finds the best evidence of market value to be the *appraisal submitted by the appellant*. The Board finds the subject property, which is <u>not</u> owner-occupied, had a market value of \$265,000 as of the assessment date at issue. Since market value has been established the 2011 three year median level of assessment for class 2 property of 9.49% as determined by the Illinois Department of Revenue shall apply. (86 Ill.Admin.Code §1910.50(c)(2).

Section 16-185 of the Property Tax Code provides in part:

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
