

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are George Capra c/o Timothy E. Moran, the appellant, by attorney Timothy E. Moran, of Schmidt Salzman & Moran, Ltd in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

> LAND: \$ 11,050 IMPR.: \$ 59,303 TOTAL: \$ 70,353

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2011 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of two improvements on a single site. Improvement #1 is a 119 year-old, two-story dwelling of masonry construction containing 1,428 square feet of living area. Features of Improvement #1 include a full unfinished basement. Improvement #2 is a 119 year-old, one-story dwelling of masonry construction. The parties differed as to the living area size of Improvement #2. Features of Improvement #2 include a full unfinished basement. The property has a 3,250 square foot site and is located in West Chicago Township, Cook County. The Docket No: 11-26790.001-R-1

property is a Class 2 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on four suggested equity comparables for each of the two improvements. The appellant disclosed Improvement #2 contained 944 square feet of living area. The appellant appended information from the Cook County Assessor obtained through a Freedom of Information request disclosing that Improvement #1 contained 1,428 square feet of living area and Improvement #2 contained 861 square feet of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$70,353. Improvement #1 has an assessment of \$37,184, or \$26.04 per square foot of living area. Improvement #2 has an assessment of \$22,119, or \$25.69 per square foot of living area when using the board of review's suggested 861 square feet of living area. The land has an assessment of \$11,050.

In support of its contention of the correct assessment, the board of review submitted information on four suggested equity comparables for Improvement #1 and on three suggested equity comparables for Improvement #2.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

As to the size of Improvement #2, the Board accepts and applies, for the purpose of this appeal, 861 square feet of living area disclosed by both the board of review and by the appellant in his evidence attached to his appeal.

The Board finds the best evidence of assessment equity for Improvement #1 to be the appellant's comparable #1, and the board of review's comparables #1 and #2. These comparables had improvement assessments that ranged from \$17.88 to \$27.44 per square foot of living area. The assessment for Improvement #1 of \$26.04 per square foot of living area falls within the range established by the best comparables in this record. The Board finds the best evidence of assessment equity for Improvement #2 Docket No: 11-26790.001-R-1

to be the appellant's comparables #2, #3 and #4, and the board of review's comparables #1 and #2. These comparables had improvement assessments that ranged from \$32.07 to \$35.75 per square foot of living area. The assessment for Improvement #2 of \$25.69 per square foot of living area falls below the range established by the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and holds that a reduction in the subject's assessment is not justified. This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
