

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Brian Murphy

The parties of record before the Property Tax Appeal Board are Brian Murphy, the appellant(s), by attorney Jason T. Shilson, of O'Keefe Lyons & Hynes, LLC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$4,375 **IMPR.:** \$8,725 **TOTAL:** \$13,100

Subject only to the State multiplier as applicable.

### Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2011 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### Findings of Fact

The subject property consists of an approximately 3,125 square foot parcel of land improved with an approximately four-year old, three-story, masonry, non-owner occupied, multi-family dwelling containing approximately 3,726 square feet of living area. The property is located in West Chicago Township, Cook County and is a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation and inequity as the bases of the appeal. In support of this argument the appellant submitted Docket No: 11-30449.001-R-1

an appraisal estimating the subject property had a market value of \$131,000 as of January 1, 2011. The appellant also submitted equity comparables. The appraisal discloses a sale for the subject in December 2010 for \$185,000.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$27,886. The subject's assessment reflects a market value of \$278,860 using the Cook County Ordinance level of assessment for class 2 property of 10%.

In support of its contention of the correct assessment the board of review submitted eight comparables with sales information on four comparables.

The board of review also listed a sale for the subject in December 2010 for \$185,000. The board of review's evidence includes a supplemental brief that the sale of the subject should be given no weight as this sale was a compulsory sale and not appellant failed to provide any evidence of the negotiation of the sale.

#### Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of market value to be the appraisal submitted by the appellant. The subject's assessment reflects a market value above the best evidence of market value in the record. Therefore, the Board finds the subject had a market value of \$131,000 and a reduction is justified. The Board further finds that after this reduction the subject is equitably assessed.

subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
