

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Liborio & Antonia Carrillo DOCKET NO.: 12-01306.001-R-1 PARCEL NO.: 15-27-229-008

The parties of record before the Property Tax Appeal Board are Liborio and Antonia Carrillo, the appellants, by attorney Jerri K. Bush of Chicago, and the Kane County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Kane** County Board of Review is warranted. The correct assessed valuation of the property is:

> LAND: \$2,027 IMPR.: \$10,923 TOTAL: \$12,950

Subject only to the State multiplier as applicable.

# Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Kane County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2012 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

# Findings of Fact

The subject property is improved with a one-story dwelling of masonry construction with 925 square feet of living area. The dwelling was constructed in 1923. Features of the home include a full basement and an open masonry porch. The property has a 3,485 square foot site and is located in Aurora, Aurora Township, Kane County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on six comparable sales described as being improved with onestory dwellings that ranged in size from 784 to 1,119 square feet of living area. The dwellings were constructed from 1900 to 1927. The sales occurred from April 2011 to June 2012 for prices ranging from \$10,000 to \$37,000 or from \$8.94 to \$42.73 per square foot of living area, including land. Based on these sales the appellant requested the subject's assessment be reduced to \$8,243.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$23,596. The subject's assessment reflects a market value of \$70,752 or \$76.49 per square foot of living area, land included, when using the 2012 three year average median level of assessment for Kane County of 33.35% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted a statement asserting that appellant's comparable sales #1 through #5 were foreclosures and that sale #6 sold in May 1990. (The appellant's grid analysis indicated that sale #6 was recorded in May 1990.) In support of the assessment the board of review submitted an equity analysis prepared by the township assessor.

## Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met meet this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the only evidence of market value to be the appellant's comparable sales. These comparables sold for prices ranging from \$8.94 to \$42.73 per square foot of living area, including land. The subject's assessment reflects a market value of \$76.49 per square foot of living area, including land, which is above the range established by the only comparable sales in this record.

The board of review asserted that appellant's comparables #1 through #5 were foreclosures. Section 1-23 of the Property Tax Code (hereinafter "the Code") defines compulsory sale as:

"Compulsory sale" means (i) the sale of real estate for less than the amount owed to the mortgage lender or mortgagor, if the lender or mortgagor has agreed to the sale, commonly referred to as a "short sale" and (ii) the first sale of real estate owned by a financial institution as a result of a judgment of foreclosure, transfer pursuant to a deed in lieu of foreclosure, or consent judgment, occurring after the foreclosure proceeding is complete. 35 ILCS 200/1-23.

Section 16-183 of the Code provides that the Property Tax Appeal Board is to consider compulsory sales in determining the correct assessment of a property under appeal stating:

Compulsory sales. The Property Tax Appeal Board shall consider compulsory sales of comparable properties for the purpose of revising and correcting assessments, including those compulsory sales of comparable properties submitted by the taxpayer. 35 ILCS 200/16-183.

Based on these statutes, the Property Tax Appeal Board finds it is appropriate to consider these sales in revising and correcting the assessment.

The board of review provided no comparable sales to demonstrate the subject's assessment was reflective of the subject's market value or to refute the appellant's overvaluation argument. The Board gives no weight to the equity comparables submitted by the board of review as this evidence did not address the appellant's overvaluation argument.

Based on this record the Board finds a reduction in the subject's assessment is appropriate.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

#### IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

Docket No: 12-01306.001-R-1

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
