

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Alex Brickman, the appellant; and the Lake County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$37,855 **IMPR.:** \$103,955 **TOTAL:** \$141,810

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2012 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame construction with 2,406 square feet of living area. The dwelling was constructed in 1989. Features of the home include a basement that has 522 square feet of finished area, central

air conditioning, a fireplace and a 420 square foot garage. The property has an 8,763 square foot site and is located in Buffalo Grove, Vernon Township, Lake County.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on three equity comparables.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$141,810. The subject property has an improvement assessment of \$103,955 or \$43.21 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four equity comparables.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code Proof of unequal treatment in the assessment §1910.63(e). process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity of distinguishing characteristics of the to the subject property. 86 Ill.Admin.Code comparables §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be board of review comparables #1, #3 and #4. These comparables were most similar to the subject in size and had some finished basement area, like the subject. The Board gave less weight to the parties' remaining comparables due to their considerably larger size and/or lack of finished basement area, unlike the The most similar comparables had improvement assessments that ranged from \$42.18 to \$46.99 per square foot of living area. The subject's improvement assessment of \$43.21 per square foot of living area falls within the range established by the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement inequitably assessed and a reduction in the subject's assessment is not justified.
