

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Kevin & Linda Coogan

The parties of record before the Property Tax Appeal Board are Kevin & Linda Coogan, the appellants, by attorney Julia Mezher, of Mar Cal Law, P.C. in Chicago; and the DuPage County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$22,020 **IMPR.:** \$29,930 **TOTAL:** \$51,950

Subject only to the State multiplier as applicable.

## Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2012 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

### Findings of Fact

The subject property consists of a one-story dwelling of brick construction with 1,075 square feet of living area. The dwelling was constructed in 1956. Features of the home include

a full basement, which is 50% finished, and a 440 square foot detached garage. The property is located in Addison, Addison Township, DuPage County.

The appellants appeared before the Property Tax Appeal Board, through counsel, contending assessment inequity regarding the subject's improvement as the basis of the appeal. In support of this argument the appellants submitted information on three equity comparables.

Counsel contended that the appellants' comparables were all ranch style dwellings like the subject and are located within five blocks of the subject property.

Based on this evidence the appellants' counsel requested the subject's total assessment be reduced to \$47,068 and the improvement assessment be reduced to \$25,048, which was calculated using the average per square foot improvement assessment of the comparables.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$51,950. The subject property has an improvement assessment of \$29,950 or \$27.84 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on six equity comparables.

At the hearing the board of review called as its witness Dawn Aderholt, Deputy Assessor for Addison Township. Aderholt testified that all of the appellants' comparables lacked basements, unlike the subject. In addition, comparable #1 has frame exterior construction and comparable #2 has brick and frame exterior construction, unlike the subject. Aderholt also testified that comparable #2 had a partial assessment temporarily reduced that year, based on a sale price that was impacted by condition issues.

Under rebuttal, the appellants' counsel argued that the board of review's comparables #1, #3, #4, #5 and #6 have central air conditioning, unlike the subject. In addition, the board of review's comparables #5 and #6 have larger garages, when compared to the subject.

#### Conclusion of Law

The taxpayers contend assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the

basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellants did not meet this burden of proof and no reduction in the subject's assessment is warranted

After hearing the testimony and considering the evidence, the Board finds the best evidence of assessment equity to be the board of review's comparables #1 thru #4. These comparables were most similar to the subject in location, style, exterior construction, foundation, size and most features. comparables had improvement assessments that ranged from \$28.68 to \$31.08 per square foot of living area. The subject's improvement assessment of \$27.84 per square foot of living area falls below the range established by the best comparables in The Board gave less weight to the appellants' this record. comparables due to their lack of a basement foundation feature, when compared to the subject. The Board gave less weight to the board of review's comparables #5 and #6 due to their larger garage, when compared to the subject. Based on this record the Board finds the appellants did not demonstrate with clear and convincing evidence that the subject's improvement inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

#### IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
