

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Sopa Anaman

The parties of record before the Property Tax Appeal Board are Sopa Anaman, the appellant, by attorney Julie Realmuto of Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds $\underline{no\ change}$ in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 3,359 **IMPR.:** \$ 12,573 **TOTAL:** \$ 15,932

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2012 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is improved with a one-story dwelling of masonry construction with 949 square feet of living area. The dwelling is approximately 60 years old. Features of the property include a full unfinished basement, central air conditioning and a two-car garage. The property has a 4,199 square foot site and is located in Berwyn, Berwyn Township, Cook County. The subject is classified as a class 2-02 property

under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement assessment as the basis of the appeal. In support of this argument the appellant submitted information on two equity comparables improved with one-story dwellings of masonry construction that have either 976 or 987 square feet of living area. The dwellings are 42 and 55 years old and each has an unfinished basement and one has central air conditioning. Each comparable has an improvement assessment pro-rated over two parcel numbers (PINs). The comparables have improvement assessments of \$11,946 and \$12,917 or \$12.10 and \$13.23 per square foot of living area. The appellant requested the subject's improvement assessment be reduced to \$6,282.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$15,932. The subject property has an improvement assessment of \$12,573 or \$13.25 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four equity comparables improved with one-story dwellings of masonry construction that range in size from 907 to 990 square feet of living area. The comparables were either 57 or 61 years old. Each comparable has a full basement with one having finished area, two comparables have central air conditioning and each comparable has a one-car or a two-car garage. The comparables have improvement assessments that range from \$12,431 to \$13,571 or from \$13.63 to \$14.18 per square foot of living area.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted six comparables that were relatively similar to the subject property in style, age, size and features. These comparables had improvement assessments that ranged from \$12.10 to \$14.18 per square foot of living area. The subject's improvement assessment of \$13.25 per square foot of living area falls within the range established by the comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
