



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Peter McCarthy

The parties of record before the Property Tax Appeal Board are Peter McCarthy, the appellant, by attorney Julie Realmuto, Attorney at Law in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$5,775
IMPR.: \$31,455
TOTAL: \$37,230

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2012 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one and one-half story dwelling of frame construction. The dwelling is approximately 56 years old and has 1,856 square feet of living area. Features of the home include a crawl-space foundation, a fireplace and a two-car garage. The property has a 6,600 square foot site and is located in Northfield, New Trier Township, Cook County. The subject is classified as a class 2-04 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted

information on four purported equity comparables. Evidence submitted by the appellant indicates that comparables #3 and #4 are actually the same dwelling with an improvement assessment allocated between the two parcels. These comparables have the same street address; consecutive parcel identification numbers; and identical improvement descriptions. Moreover, photographs of these comparables depict the same home.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$37,230. The subject property has an improvement assessment of \$31,455 or \$16.95 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted information on a total of seven suggested equity comparables. The appellant's comparables #1 and #2 had improvement assessments that were outliers at \$5.96 and \$6.90 per square foot of living area, respectively. Board of review comparable #1 differed from the subject in design and foundation, and #4 differed from the subject in foundation and age. Consequently, these four comparables received reduced weight in the Board's analysis. The Board finds the best evidence of assessment equity to be appellant's comparables #3/4 and board of review comparable #2. These comparables did not have basements and were also similar to the subject in location, design, exterior construction, age and living area. As further support, board of review comparable #3, despite differing in foundation, was also similar to the subject in location, design and living area. These three comparables had improvement assessments that ranged from \$16.36 to \$17.23 per square foot of living area. The subject's improvement assessment of \$16.95 per square foot of living area falls within the range established by the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
