

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Jay Levey DOCKET NO.: 12-29179.001-R-1 PARCEL NO.: 03-23-318-014-0000

The parties of record before the Property Tax Appeal Board are Jay Levey, the appellant; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2012 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is a 24 year-old, two-story dwelling of frame and masonry construction containing 2,982 square feet of living area. Features of the home include a full finished basement, air conditioning, a fireplace and a two-car garage. The property has a 20,000 square foot site and is located in Wheeling Township, Cook County. property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on four comparable sales. The appellant's evidence disclosed the subject sold in August 2004.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$50,904. The subject's assessment reflects a market value of \$525,325, or \$176.17 per square foot of living area including land, when applying the 2012 three-year median level of assessment for Class 2 property of 9.69% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on four suggested sale comparables. The board of review also disclosed the sale of the subject for \$387,000, but without providing information about the date of the sale.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist appraisal of the subject property, a recent of an sale, comparable sales or construction costs. 86 Ill.Admin.Code The Board finds the appellant met this burden of §1910.65(c). proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of market value to be the appellant's comparable sales #1, #3 and #4. These comparables sold for prices ranging from \$115.38 to \$157.14 per square foot of living area, including land. The subject's assessment reflects a market value of \$176.17 per square foot of living area including land, which is above the range established by the best comparable sales in this record. The 2004 sale of the subject is too remote in time to be a recent sale comparable. Based on this evidence, the Board finds a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

Docket No: 12-29179.001-R-1

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
