

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Linh Mai Tran, the appellant, by attorney Christopher G. Walsh, Jr., Attorney at Law in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$ 4,612
IMPR.:	\$12,147
TOTAL:	\$16,759

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2012 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is a 104 year-old, two-story dwelling of masonry construction containing 2,262 square feet of living area. Features of the home include a full finished basement and a two-car garage. The property has a 3,844 square foot site and is located in West Chicago Township, Cook County. The property is a Class 2 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant's appeal is based on overvaluation. In support of this argument, the appellant submitted evidence disclosing the subject property was purchased on January 25, 2012 for a price of \$85,000. The appellant submitted the PTAX-203 Illinois Real Estate Transfer Declaration disclosing the transaction was a short sale, an affidavit from the appellant asserting that he purchased the subject for its fair market value, and partial information in Section IV – Recent Sale Data of the Residential Appeal that the subject was advertised for sale on the

Multiple Listing Service, was not a transfer between related parties and was sold in settlement of a contract for deed. Based on this evidence, the appellant requested a reduction in the subject's assessment to reflect the purchase price when using the 2012 level of assessment of 10.00% for Class 2 property under the Cook County Real Property Assessment Classification Ordinance.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$16,759. The subject's assessment reflects a market value of \$167,590 or \$74.09 per square foot of living area when using the level of assessment of 10.00% for Class 2 property under the Cook County Real Property Assessment Classification Ordinance. The subject's sale price of \$85,000 reflects a market value of \$37.58 per square foot of living area including land.

In support of its contention of the correct assessment, the board of review submitted information on four suggested comparable sales that sold from 2009 through 2011 for prices ranging from \$85.03 to \$110.08 per square foot of living area including land. The board of review also submitted a brief arguing the subject's sale was not for fair cash value and, therefore, was compulsory. The board of review appended to its brief evidence that a *lis pendens* notice and notice of foreclosure were filed by JP Morgan Chase Bank against Mauro Argudo on January 20, 2010, that the mortgagee JP Morgan Chase Bank recorded a *lis pendens* against the property on January 27, 2010, and that a deed was transferred by Mauro Argudo to the appellant Linh Mai Tran and recorded on February 1, 2011. The board of review also appended the transfer tax declaration disclosing the transaction was a short sale.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant has not met this burden of proof and a reduction in the subject's assessment is not warranted.

In addressing the appellant's market value argument, the Board finds that the sale of the subject in January 2012 for \$85,000 is a "compulsory sale." A "compulsory sale" is defined as:

(i) the sale of real estate for less than the amount owed to the mortgage lender or mortgagor, if the lender or mortgagor has agreed to the sale, commonly referred to as a "short sale" and (ii) the first sale of real estate owned by a financial institution as a result of a judgment of foreclosure, transfer pursuant to a deed in lieu of foreclosure, or consent judgment, occurring after the foreclosure proceeding is complete.

35 ILCS 200/1-23. Real property in Illinois must be assessed at its fair cash value, which can only be estimated absent any compulsion on either party.

Illinois law requires that all real property be valued at its fair cash value, estimated at the price it would bring at a fair voluntary sale where the owner is

ready, willing, and able to sell but not compelled to do so, and the buyer is likewise ready, willing, and able to buy, but is not forced to do so.

Bd. of Educ. of Meridian Cmty. Unit Sch. Dist. No. 223 v. Ill. Prop. Tax Appeal Bd., 961 N.E. 2d 794, 802 (2d Dist. 2011) (citing Chrysler Corp. v. Ill. Prop. Tax Appeal Bd., 69 Ill. App. 3d 207, 211 (2d Dist. 1979)).

The evidence submitted by the board of review disclosed the subject's sale was compulsory. However, when there was a recent sale of the subject, and that sale was compulsory, the Board may consider evidence which would show whether the sale price was representative of the subject's fair cash value. *See* 35 ILCS 200/16-183. The appellant did not submit additional sale comparables to show that the sale of the subject in January 2012 for \$85,000 was at its fair cash value. The affidavit of the appellant asserting he paid fair market value is an opinion for which there is no evidence he is qualified to make. Moreover, the board of review submitted sale comparables that contained property characteristics similar to the subject's and sold for prices ranging from \$85.03 to \$110.08 per square foot of living area, including land. The subject's assessment reflects a market value of \$74.09 per square foot of living area including land, which is below the range established by the best comparable sales in this record. Further, the board of review's sale comparables establish that the subject's purchase price was below its fair cash value. Since there is no supporting evidence that the sale price of the subject was at its fair cash value, the Board finds that the subject is not overvalued and holds that a reduction is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
