

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: OSP II Palmer, LLC DOCKET NO.: 12-30568.001-R-1 PARCEL NO.: 13-35-215-024-0000

The parties of record before the Property Tax Appeal Board are OSP II Palmer, LLC, the appellant, by attorney David R. Bass, of Field and Goldberg, LLC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$11,812 **IMPR.:** \$98,175 **TOTAL:** \$109,987

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2012 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

### Findings of Fact

The subject property consists of a four-story apartment building with 12,340 square feet of living area. The building was constructed in 2006. The property has a 7,500 square foot site and is located in Chicago, Jefferson Township, Cook County. The subject is classified as a class 3-15 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant's appeal is based on overvaluation. In support of this argument the appellant submitted limited evidence disclosing the subject property was purchased on July 19, 2010 for a price of \$615,000. Based on this evidence, the appellant requested a reduction in the subject's assessment to reflect the purchase price.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$109,987. The subject's assessment reflects a market value of

\$1,099,870 or \$89.13 per square foot of living area, land included, when using the level of assessments for class 3 property of 10% under the Cook County Real Property Assessment Classification Ordinance.

In support of its contention of the correct assessment the board of review submitted information on five comparable sales.

The appellant submitted a rebuttal brief critiquing the board of review's submission.

#### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of market value in the record to be the board of review's comparable sale #4. This comparable was similar to the subject in location, style, construction, features and land area. This property also sold proximate in time to the assessment date at issue. The comparable sold for a price of \$970,200 or \$94.70 per square foot of living area, including land. The subject's assessment reflects a market value of \$89.13 per square foot of living area, including land, which is supported by the best comparable sales in this record. The Board gave little weight to the subject's sale due to its occurrence greater than 17 months prior to the January 1, 2012 assessment date. In addition, the appellant failed to complete Section IV - Recent Sale Data of the appeal. The Property Tax Appeal Board's appeal form is not vague as to whether Section IV is to be completed when arguing overvaluation based on a recent sale. The appellant disclosed the parties to the transaction were not related and the property was sold by the owner, however, the appellant did not disclose whether the subject was advertised on the open market, the manner in which the property was marketed and the length of time the subject was marketed. The appellant submitted a copy of the PTAX-203 Illinois Real Estate Transfer Declaration and an affidavit from the appellant, however, neither of these documents discloses the length of market exposure, which is an important element of determining whether an arm's length transaction occurred. The Board gave less weight to the remaining sales presented by the board of review due to their sale dates occurring greater than 41 months prior to the assessment date at issue. Based on this record the Board finds the subject's assessment is reflective of market value and a reduction in the subject's assessment is not justified.

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
