

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Kevin Coogan DOCKET NO.: 13-03970.001-R-1 PARCEL NO.: 03-16-304-035

The parties of record before the Property Tax Appeal Board are Kevin Coogan, the appellant, by attorney Richard J. Caldarazzo of Mar Cal Law, P.C., in Chicago; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$ 95,750 **IMPR.:** \$ 35,200 **TOTAL:** \$130,950

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2013 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a one-story frame dwelling that has 1,135 square feet of living area. The dwelling was constructed in 1935. Features include an unfinished basement, central air conditioning and a 528 square foot attached garage. The subject property is located in Addison Township, DuPage County, Illinois.

The appellant submitted evidence before the Property Tax Appeal Board claiming assessment inequity as the basis of the appeal. In support of the inequity claim, the appellant submitted information for three assessment comparables located in close proximity to the subject. The comparables consist of one-story style dwellings of brick, frame, or brick and frame exterior construction that were built from 1955 to 1964. One comparable has central air conditioning and all the comparables have attached or detached garages that contain from 330 to 528 square feet of building area. The dwellings range in size from 1,186 to 1,785 square feet of living area and

have improvement assessments ranging from \$31,420 to \$50,220 or from \$20.55 to \$28.13 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject property of \$130,950. The subject property has an improvement assessment of \$35,200 or \$31.01 per square foot of living area. In support of the subject's assessment, the board of review submitted an equity analysis of six assessment comparables located in close proximity along the subject's street. The comparables are improved with one-story brick dwellings that were built in 1957 or 1960. Two comparables have full unfinished basements and four comparables have full basements that are 75% finished. All the comparables have central air conditioning and detached garages that contain from 440 to 572 square feet of building area. One comparable has a fireplace. The dwellings range in size from 1,232 to 1,571 square feet of living area and have improvement assessments ranging from \$39,500 to \$50,080 or from \$31.88 to \$34.80 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

## **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant failed to meet this burden of proof and no reduction in the subject's assessment is warranted.

The record contains nine assessment comparables for the Board's consideration. The Board gave less weight to the comparables submitted by the appellant. None of the comparables have basements, inferior to the subject. Additionally, comparables #1 and #3 are larger in dwelling size when compared to the subject. The Board also gave less weight to comparable #1 submitted by the board of review due to its larger dwelling size when compared to the subject. The Board finds the five remaining comparables submitted by the board of review were most similar when compared to the subject in location, design, age, dwelling size and features. These comparables have improvement assessments ranging from \$39,500 to \$44,620 or from \$32.06 to \$34.80 per square foot of living area. The subject property has an improvement assessment of \$35,200 or \$31.01 per square foot of living area, which falls below the range established by the most similar assessment comparables contained in the record. After considering adjustments to the comparables for any differences when compared to the subject, the Board finds the subject's improvement assessment is supported. Therefore, no reduction in the subject's assessment is warranted.

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
