



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Loreto Burcaro

The parties of record before the Property Tax Appeal Board are Loreto Burcaro, the appellant, by attorneys Richard J. Caldarazzo and Ryan Schaeffges, of Mar Cal Law, P.C. in Chicago; and the DuPage County Board of Review; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$27,360  
**IMPR.:** \$82,070  
**TOTAL:** \$109,430

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2013 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a two-story dwelling of masonry construction with 3,900 square feet of building area. The dwelling was constructed in 1960. The building has six apartments. The property has a 10,936 square foot site and is located in Wood Dale, Addison Township, DuPage County.

Ryan Schaeffges appeared before the Property Tax Appeal Board on behalf of the appellant contending assessment inequity as the basis of the appeal.<sup>1</sup> In support of this argument the appellant submitted limited information on three equity comparables improved with two-story

multi-family buildings of masonry construction that were built from 1962 to 2000. The buildings range in size from 2,850 to 4,250 square feet of building area and had either 2 apartments or 6 apartments.<sup>2</sup> These properties had total assessments that range from \$69,450 to \$109,430 or from \$18,238 to \$35,395 per unit and improvement assessments that range from \$52,090 to \$82,070 or from \$17.04 to \$19.31 per square foot of building area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$109,430 or \$18,238 per unit. Representing the board of review was Board of Review Chairman, Anthony Bonavolonta. In support of its contention of the correct assessment the board of review submitted a copy of the 2011 Property Tax Appeal Board Decision.

### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The appellant submitted three equity comparables with limited information for the Board's consideration. The Board gave less weight to the appellant's comparables #1 and #2 due to these comparables having two apartment units when compared to the subject's six apartment units. The Board finds the best evidence of assessment equity to be appellant's comparable #3. This comparable is identical in number of apartment units and similar in age when compared to the subject. This comparable has a total assessment of \$109,430 or \$18,238 per apartment unit. The subject's total assessment of \$109,430 or \$18,238 per apartment unit is identical to the best comparable in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
