

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Gerald Forsythe New Midwest Hotels Mattoon S, LLC

DOCKET NO.: 13-04327.001-C-3 PARCEL NO.: 06-0-04656-000

The parties of record before the Property Tax Appeal Board are Gerald Forsythe New Midwest Hotels Mattoon S, LLC, the appellant, by attorney Patrick J. Cullerton of Thompson Coburn, LLP, in Chicago; and the Coles County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Coles** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 93,950 **IMPR.:** \$258,220 **TOTAL:** \$352,170

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Coles County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2013 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a three-story limited service 70 unit hotel with 40,127 square feet of building area. The hotel was constructed in 2000. The subject property has a 1.29

acre site. The subject property is located in Lafayette Township, Coles County, Illinois.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted an appraisal estimating the subject property had a market value of \$1,050,000 as of January 1, 2013. The appraiser developed the income and sales comparison approaches to value in arriving at the final opinion of value.

The appellant also submitted the final decision issued by the Coles County Board of Review disclosing the subject's final assessment of \$752,720. The subject's assessment reflects an estimated market value of \$2,244,246 when applying Coles County's 2013 three-year median level of assessment of 33.54%. Based on this evidence, the appellant requested the subject's assessment be reduced to reflect the appraised value.

The board of review did not submit its "Board of Review Notes on Appeal" or any evidence in support of its assessment of the subject property as required by section 1910.40(a) of the rules of the Property Tax Appeal Board. 86 Ill.Admin.Code §1910.40(a). Therefore, the board of review was found to be in default pursuant to section 1910.69(a) of the rules of the Property Tax Appeal Board. 86 Ill.Admin.Code §1910.69(a).

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant has met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the only evidence of market value contained in this record is the appraisal submitted by the appellant estimating the subject property had a market value of \$1,050,000 as of January 1, 2013. The subject's assessment reflects a market value of \$2,244,246, which is greater than the appraised value as submitted by the appellant. The board of review did not submit any evidence in support of its assessment of the subject property or refute the value evidence submitted by the

appellant. 86 Ill.Admin.Code $\S1910.40(a)$. As a result, the board of review was found to be in default pursuant to section 1910.69(a) of the rules of the Property Tax Appeal Board. 86 Ill.Admin.Code $\S1910.69(a)$. Based on this evidence, the Board finds a reduction in the subject's assessment is warranted. Since market value has been established, Coles County's 2013 three-year average median level of assessment of 33.54% as determined by the Illinois Department of Revenue shall apply. 86 Ill.Admin.Code $\S1910.50(c)(1)$.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
