



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Leigh & Michael Holzman, the appellant(s), by attorney Thomas J. Thorson, of Raila & Associates, P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds A Reduction in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$11,200
IMPR.: \$53,958
TOTAL: \$65,158

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2013 tax year. The Property Tax Appeal Board (Board) finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 7,000 square foot parcel of land improved with a 94-year old, three-story, masonry, multi-family building containing 9,345 square feet of building area. The property is located in Rodgers Park Township, Cook County and is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted sales information on three comparables as well as a market analysis summary.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$85,486. The subject's total assessment reflects a market value of

\$854,860 or \$91.48 per square foot of building area using the Cook County Ordinance level of assessment of 10% for class 2 properties.

In support of its contention of the correct assessment the board of review submitted two sales comparables. In addition, the board of review submitted a supplemental brief with a motion requesting that the Board finds the appellant's evidence is not an appraisal and dismiss the appeal.

Conclusion of Law

As to the board of review's motion, the Board grants it in part and denies it in part. The Board finds that the appellant's evidence is not an appraisal and gives no weight to the charts and graphs contained in the analysis. However, the Board of review denies the motion to dismiss and will look only to the raw sales data submitted by the appellant to determine the weight to give this evidence.

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c).

The Board finds the best evidence of market value are the appellant's comparables. These properties sold from January 2011 to October 2013 for prices ranging from \$42.98 to \$66.20 per square foot of building area. In comparison, the appellant's assessment reflects a market value of \$91.48 per square foot of building area which is above the range established by the comparables. Based on the record and after adjustments to the comparables, the Board finds the appellant did demonstrate by a preponderance of the evidence that the subject was overvalued and a reduction to that requested by the appellant is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
