

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Vida Goodman

The parties of record before the Property Tax Appeal Board are Vida Goodman, the appellant(s); and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

#### Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2013 tax year. The Property Tax Appeal Board (the "Board") finds that it has jurisdiction over the parties and the subject matter of the appeal.

## Findings of Fact

The subject consists of a condominium unit with a 5.75% ownership interest in the common elements (PIN -1008), and, presumably, an associated parking space with a 1.10% ownership interest in the common elements (PIN -1017). The property is located in Countryside, Lyons Township, Cook County. The subject is classified as a class 2-99 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted an appraisal estimating the condominium unit had a market value of \$76,000 as of March 5, 2013. The appraisal did not discuss the PIN ending in -1017. The appraisal, does, however, state that the PIN ending in -1008 contains an outdoor parking space.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$10,612. The subject's assessment reflects a market value of \$105,487 when applying the 2013 three year average median level of assessment for class 2 property under the Cook County Real Property Assessment Classification Ordinance of 10.06% as determined by the Illinois Department of Revenue.

In support of the subject's assessment, the board of review submitted a printout showing the assessment information for all 34 units within the subject's condominium association. The printout also includes a sale of one of those units from March 2006.

### Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of market value to be the appraisal submitted by the appellant. The subject's assessment reflects a market value above the best evidence of market value The Board finds the subject property had a in the record. market value of \$76,000 as of the assessment date at issue. Since market value has been established the 2013 three year average median level of assessment for class 2 property under Cook County Real Property Assessment Classification Ordinance of 10.06% as determined by the Illinois Department of Ill.Admin.Code §1910.50(c)(2). shall 86 apply. Additionally, the Board finds that, although the appraisal did not include the PIN ending in -1017, it nonetheless included the parking space in the appraisal's final conclusion of value. As such, the Board finds that a reduction in assessment is

warranted for both PINs under appeal to reflect the best evidence of market value.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
