



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Louis L. Kenyeri, the appellant(s), by attorney Abby L. Strauss, of Schiller Strauss & Lavin PC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$5,605  
**IMPR.:** \$26,990  
**TOTAL:** \$32,595

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2013 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a one-story, town home dwelling of masonry construction with 2,266 square feet of living area. The subject consists of two improvement each containing 1,133 square feet of living area. The dwelling was constructed in 1956. The property has a 8,624 square foot site and is located in Park Ridge, Maine Township, Cook County.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables regarding one improvement.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$32,595. The subject property has a total improvement assessment of \$26,990 or \$23.82 per square foot of living area. The subject has an improvement assessment is \$11.91 per square foot of living area per each improvement. In support of the assessment, the

board of review submitted the same four equity comparables for both improvements. In addition, the board of review's evidence included the ASIQ printouts showing two improvements on the subject's parcel of land.

### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be the board of review's comparables for each improvement. The board of review's comparables are similar in size, features, and located one the same block as the subject. These comparables had improvement assessments that ranged from \$13.41 to \$13.61 per square foot of living area. The subject's improvement assessment of \$11.91 per square foot of living area falls below the range established by the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.
