

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Hispanic Housing Development Corp.

The parties of record before the Property Tax Appeal Board are Hispanic Housing Development Corp., the appellant(s), by attorney Timothy E. Moran, of Schmidt Salzman & Moran, Ltd in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$2,557 **IMPR.:** \$1,343 **TOTAL:** \$3,900

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2013 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story, single-family dwelling of frame and masonry construction with 1,605 square feet of living area. Features of the dwelling include a slab basement, one fireplace, two baths, and a two car garage. The dwelling was constructed in 1920. The property has a 16,100 square foot site and is located in Thornton, Thornton Township, Cook County.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on five equity comparables.

The appellant's appeal is also based on overvaluation. The appellant's brief and Section IV-Recent Sale Data of the appeal stated that the subject sold on September 25, 2012 for \$39,000 and that the transaction was not between related parties.. In support, the appellant submitted a copy of the

settlement statement and real estate contract. Appellant requested that the Board apply a 10% level of assessment as determined by the Cook County Real Property Classification Code.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$8,271. The subject property has an improvement assessment of \$5,714 or \$3.56 per square foot of living area. The subject's assessment reflects a market value of \$57,140 or \$35.60 per square foot of living area, land included, when using the level of assessment of 10% as determined by the Cook County Real Property Classification Code.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables and sales data for each comparable.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of market value to be the purchase of the subject property in September 2013 for 39,000. The appellant provided evidence demonstrating the sale had the elements of arm's length transaction and in support of the transaction, copies of the settlement statement and real estate contract were submitted. Lastly, the board of review failed to provide any substantial evidence to challenge the arm's length nature of the transaction.

Based on this record, the Board finds the subject property had a market value of \$39,000 as of January 1, 2013. Since market value has been determined, the level of assessments for class 2-03, residential property of 10% shall apply as determined by the Cook County Classification Code shall apply. After the market value reduction, the Board finds the subject is equitably assessed.

session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
