

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Armida Dati

The parties of record before the Property Tax Appeal Board are Armida Dati, the appellant; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$ 8,752 **IMPR.:** \$18,091 **TOTAL:** \$26,843

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2014 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a one-story frame condominium unit that has 1,030 square feet of living area. The dwelling was constructed in 1987. Features include central air conditioning and a 300 square foot attached garage. The subject property is located in Libertyville Township, Lake County, Illinois.

The appellant submitted evidence before the Property Tax Appeal Board claiming assessment inequity as the basis of the appeal. In support of the inequity claim, the appellant submitted information on three assessment comparables located in close proximity to the subject. The comparables consist of one-story condominiums of frame exterior construction that were built in 1987. Features had varying degrees of similarity when compared to the subject. The dwellings each contain 1,030 square feet of living area and have improvement assessments ranging from

\$11,899 to \$16,574 or from \$11.55 to \$16.09 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$26,843. The subject property has an improvement assessment of \$18,091 or \$17.56 per square foot of living area. In support of the subject's assessment, the board of review submitted an equity analysis of eight assessment comparables located in close proximity to the subject. The comparables are improved with one-story condominiums of frame exterior construction that were built from 1986 to 1988. Features had varying degrees of similarity when compared to the subject. The dwellings each contain 1,030 square feet of living area and have an improvement assessment of \$18,091 or \$17.56 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

## **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant failed to meet this burden of proof and no reduction in the subject's assessment is warranted.

The record contains eleven assessment comparables for the Board's consideration. The Board finds the both parties' comparables were similar if not identical to the subject in location, design, age, dwelling size and features. The comparables have improvement assessments ranging from \$11,899 to \$18,091 or from \$11.55 to \$17.56 per square foot of living area. The subject property has an improvement assessment of \$18,091 or \$17.56 per square foot of living area, which falls within the range established by both parties' assessment comparables and is identical to eight of the eleven comparables contained in the record. Therefore, no reduction in the subject's improvement assessment is warranted.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
