

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Brian Coogan, the appellant, by attorney Richard J. Caldarazzo, of Mar Cal Law, P.C. in Chicago; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$35,520 **IMPR.:** \$38,600 **TOTAL:** \$74,120

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2014 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is improved with a split-level style dwelling of frame and masonry exterior construction with 1,227 square feet of living area. The dwelling was constructed in 1967. Features of the home include a partial finished basement, central air conditioning and a 440 square foot detached garage. The property has a 7,425 square foot site and is located in Itasca, Addison Township, DuPage County.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on three equity comparables located within 5.5 blocks from the subject property. The comparables are improved with a split-level style dwelling of frame and masonry exterior construction that were constructed from 1958 to 1972. Features had varying degrees of similarity when compared to the subject. The dwellings range in size from 1,060 to 2,082 square feet of living area and have improvement assessments ranging

from \$31,170 to \$61,600 or from \$29.41 to \$30.65 per square foot of living area. Based on this evidence, the appellant requested the total assessment be reduced to \$72,183.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$74,120. The subject property has an improvement assessment of \$38,600 or \$31.46 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on five equity comparables located in the same neighborhood as the subject property. The comparables are improved with a split-level style dwelling of frame and masonry exterior construction that were constructed from 1940 to 1975. Features had varying degrees of similarity when compared to the subject. The dwellings range in size from 1,120 to 1,344 square feet of living area and have improvement assessments ranging from \$36,030 to \$42,280 or \$31.46 and \$32.17 per square foot of living area. Based on this evidence, the board of review requested confirmation

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight comparable sales for the Board's consideration. The Board gave less weight to the appellant's comparable #2 due to the difference from the subject in size. The Board also gave less weight to the board of review's comparable #2 due to the older age when compared to the subject property. The Board finds the appellant's comparables #1 and #3 along with the board of review's comparables #1, #3, #4 and #5 are more similar when compared to the subject in location, age, dwelling size, design, exterior construction and features. These comparables had improvement assessments that ranged from \$29.41 to \$32.17 per square foot of living area. The subject's improvement assessment of \$31.46 per square foot of living area falls within the range established by the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
