

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Salvatore Faraone DOCKET NO.: 14-03545.001-R-1 PARCEL NO.: 03-24-301-122

The parties of record before the Property Tax Appeal Board are Salvatore Faraone, the appellant, by attorney Richard J. Caldarazzo of Mar Cal Law, P.C., in Chicago; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 33,960 **IMPR.:** \$ 71,530 **TOTAL:** \$105,490

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2013 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story brick and frame dwelling that has 2,520 square feet of living area. The dwelling was constructed in 2003. Features include 3.5 bathrooms, an unfinished basement, central air conditioning, a fireplace, a wraparound porch and a 748 square foot attached garage. The subject property is located in Addison Township, DuPage County, Illinois.

The appellant submitted evidence before the Property Tax Appeal Board claiming assessment inequity as the basis of the appeal. In support of the inequity claim, the appellant submitted descriptive information for three assessment comparables located in close proximity to the subject. The comparables consist of two-story style dwellings of brick or brick and frame exterior construction that were built from 1988 to 1997. Features had varying degrees of similarity when compared to the subject. The dwellings range in size from 2,524 to 2,939 square

feet of living area and have improvement assessments ranging from \$64,270 to \$76,900 or from \$24.70 to \$26.17 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject property of \$105,490. The subject property has an improvement assessment of \$71,530 or \$28.38 per square foot of living area. In support of the subject's assessment, the board of review submitted an equity analysis of five assessment comparables located in close proximity to the subject. The comparables are improved with two-story style dwellings of brick or brick and frame exterior construction that were built from 1999 to 2003. Features had varying degrees of similarity when compared to the subject. The dwellings range in size from 2,432 to 2,983 square feet of living area and have improvement assessments ranging from \$67,690 to \$83,050 or from \$27.82 to \$28.32 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant failed to meet this burden of proof and no reduction in the subject's assessment is warranted.

The record contains eight assessment comparables for the Board's consideration. The Board gave less weight to comparables #1 and #3 submitted by the appellant due to their older age when compared to the subject. In addition, comparable #3 is larger in dwelling size when compared to the subject. The Board also gave less weight to comparables #4 and #5 submitted by the board of review due to their larger dwelling size when compared to the subject. The Board finds the four remaining comparables were most similar when compared to the subject in location, design, age, dwelling size and most features. However, these comparables have one less bathroom and lack a wraparound porch when compared to the subject. These comparables have improvement assessments ranging from \$64,270 to \$73,900 or from \$25.46 to \$28.32 per square foot of living area. The subject property has an improvement assessment of \$71,530 or \$28.38 per square foot of living area, which falls within the range established by the most similar assessment comparables on an overall basis, but slightly above the range on a per square foot basis. After considering adjustments to the comparables for their inferior characteristics when compared to the subject, the Board finds the subject's improvement assessment is justified. Therefore, no reduction in the subject's improvement assessment is warranted.

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
