



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Lynn Kenny, the appellant, by attorney John S. Xydakis of the Law Offices of John S. Xydakis in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$1,600
IMPR.: \$9,500
TOTAL: \$11,100

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2014 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of frame construction with 1,119 square feet of living area. The dwelling is approximately 63 years old. Features of the home include a crawl-space foundation, central air conditioning and a two-car garage. The property has a 4,000 square foot site and is located in Hometown, Worth Township, Cook County. The subject is classified as a class 2-10 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables. The comparable dwellings are 63 or 64 years old and contain from 1,180 to 1,396 square feet of living area. The comparables have improvement assessments ranging from \$6,307 to \$9,520 or from \$4.68 to \$7.17 per square foot of living area. The appellant also submitted a map showing the location of

the subject property and the comparable properties. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$7,564 or \$6.76 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$11,953 was disclosed. The subject property has an improvement assessment of \$10,353 or \$9.25 per square foot of living area. The board of review presented descriptions and assessment information on four suggested comparable properties. Based on their street addresses, these comparables were located in the block across the street from the subject property. The dwellings are 63 years old and contain from 1,152 to 1,173 square feet of living area. These properties have improvement assessments ranging from \$9,778 to \$10,282 or from \$8.42 to \$8.89 per square foot of living area. Based on this evidence, the board of review indicated it would stipulate to a revised improvement assessment of \$9,500 or \$8.49 per square foot of living area.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds a reduction in the subject's improvement assessment is appropriate.

The parties presented assessment data on a total of eight suggested comparables. The Board finds that all of the comparables submitted were very similar to the subject in almost all characteristics. However, the appellant's comparables #1 through #3 had significantly more living area than the subject and received reduced weight in the Board's analysis. Although the appellant's map indicated comparable #4 was located 0.3 mile from the subject property, the board of review comparables were located in the block across the street from the subject. Consequently, the Board finds the best evidence of assessment equity to be the board of review comparables, due to their superior location. The Board finds these comparables were also very similar to the subject in all other characteristics except central air conditioning. These comparables had improvement assessments that ranged from \$8.42 to \$8.89 per square foot of living area. The subject's improvement assessment of \$9.25 per square foot of living area falls above the range established by the best comparables in this record. The board of review proposed to reduce the subject's assessment based on the comparables in the record. Based on this record, the Board finds a reduction in the subject's assessment commensurate with the board of review's proposed revision is appropriate.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
