

## FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Anselmo Saucedo, the appellant(s), by attorney John S. Xydakis, of the Law Offices of John S. Xydakis in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$ 3,024
IMPR.:	\$18,442
TOTAL:	\$21,466

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2014 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

### **Findings of Fact**

The subject property consists of two improvements on one parcel of land. Improvement #1 is a one-story dwelling of masonry construction with 852 square feet of living area. The dwelling was constructed in 1914. Features of the home include a full basement. Improvement #2 is a one story dwelling of masonry construction containing 660 square feet of living area. The dwelling was constructed in 1922. The property has a 3,780 square foot site and is located in Berwyn Township, Cook County. The subject is classified as a class 2-02 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables for improvement #1. The appellant's comparables range: in building size from 920 to 995 square feet of living area; in age from 89 to 97 years; and in improvement assessments from \$6.06 to \$7.69 per square foot of

living area. No comparables were submitted for improvement #2. The appellant identifies the subject's improvement assessment for building #1 as \$18,442 which is mathematically incorrect.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$21,466. The subject property has an improvement assessment of \$18,442. The board of review indicated that the subject property has two improvements. Improvement #1 has 852 square feet of living area and has an improvement assessment of \$14.33 per square foot of living area. Improvement #2 has 660 square feet of living area and has an improvement assessment of \$9.45 per square foot of living area. In support of its contention of the correct assessment for improvement #1, the board of review submitted information on four equity comparables. The board of review's comparables range: in building size from 438 to 843 square feet; in age from 92 to 106 years; and in improvement assessments from \$14.99 to \$16.29 per square foot of living area; in age from 92 to 106 years; and in improvement assessments range: in building size from 438 to 843 square feet of living area; in age from 92 to 106 years; and in improvement assessments range: in building size from 438 to 843 square feet of living area; in age from 92 to 106 years; and in improvement assessments range: in building size from 438 to 843 square feet of living area; in age from 92 to 106 years; and in improvement assessments from \$14.99 to \$16.29 per square foot of living area.

# **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant *did not meet* this burden of proof and a reduction in the subject's assessment *is not* warranted.

Initially, the Board finds the taxpayer did not appeal the assessment for improvement #2, while the board of review submitted comparables in support of that assessment. As to improvement #1, the Board finds the best evidence of assessment equity to be *appellant's comparables #1 and #4 and the board of review's comparable #3*. These comparables had improvement assessments that ranged from \$6.06 to \$14.99 per square foot of living area. The subject's improvement assessment for improvement #1 of \$14.33 per square foot of living area falls *within* the range established by the best comparables in this record. Based on this record the Board finds the appellant *did not* demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment *is not* justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
