

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Wes Benak, the appellant, by attorney John S. Xydakis of the Law Offices of John S. Xydakis in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$2,646 **IMPR.:** \$15,793 **TOTAL:** \$18,439

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2014 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one and one-half story dwelling of masonry construction with 1,125 square feet of living area. The dwelling is approximately 70 years old. Features of the home include a full unfinished basement and a one-car garage. The property has a 5,040 square foot site and is located in Brookfield, Proviso Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables. The comparable dwellings are from 62 to 65 years old and contain from 1,270 to 1,374 square feet of living area. The comparables have improvement assessments ranging from \$13,670 to \$14,490 or from \$10.55 to \$11.06 per square foot of living area. Based on this evidence, the appellant requested a

reduction in the subject's improvement assessment to \$12,240 or \$10.88 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$18,439 was disclosed. The subject property has an improvement assessment of \$15,793 or \$14.04 per square foot of living area. The board of review presented descriptions and assessment information on four suggested comparable properties. The dwellings are from 65 to 89 years old and contain from 1,080 to 1,251 square feet of living area. These properties have improvement assessments ranging from \$15,740 to \$18,067 or from \$14.25 to \$14.57 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

Both parties presented assessment data on a total of eight suggested comparables. The Board finds the appellant's comparables #2 through #4 differed from the subject in foundation and received reduced weight in the Board's analysis. Board of review comparables #1 and #3 were significantly older than the subject and also received reduced weight. The Board finds the best evidence of assessment equity to be the appellant's comparable #1 and board of review comparables #2 and #4. The Board finds these comparables had full basements like the subject and were also similar in design, location, age and living area. These comparables had improvement assessments that ranged from \$10.55 to \$14.57 per square foot of living area. The subject's improvement assessment of \$14.04 per square foot of living area falls within the range established by the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
