

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Stark Properties, the appellant; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$2,155 **IMPR.:** \$11,148 **TOTAL:** \$13,303

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2014 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of frame exterior construction with 904 square feet of living area. The dwelling was constructed in 1967. Features of the home include a crawl-space foundation and a one-car garage. The property has a 7,837 square foot site and is located in Streamwood, Hanover Township, Cook County. The subject is classified as a class 2-02 property under the Cook County Real Property Assessment Classification Ordinance

The appellant's appeal is based on overvaluation. In support of the overvaluation argument, the appellant submitted eight comparable sales located within 1.44 miles from the subject property. The comparables consist of one-story dwellings that were constructed from 1958 to 1969. The comparables had features with varying degrees of similarity when compared to the subject. The dwellings range in size from 893 to 986 square feet of living area. The comparables sold from April 2013 to March 2014 for prices ranging from \$47,000 to \$78,500 or from \$52.63 to \$87.91 per square foot of living area including land. The submission also included a grid of "Property

Equalization Values" purporting to adjust the comparables. Based on this evidence, the appellant requested the total assessment be reduced to \$6,224.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$13,303. The subject's assessment reflects a market value of \$133,030 or \$147.16 per square foot of living area, land included, when applying the 10% level of assessment for class 2 residential property pursuant to the Cook County Real Property Assessment Classification Ordinance. In support of the subject's assessment, the board of review submitted information on four sales comparables located within the same neighborhood assessment code as the subject property. The comparables consist of one-story dwellings of frame exterior construction that range in age from 45 to 52 years old. The comparables had features with varying degrees of similarity when compared to the subject. The dwellings range in size from 775 to 925 square feet of living area and are situated on sites ranging in size from 6,600 to 9,000 square feet of land area. These comparables sold from February 2013 to July 2013 for prices ranging from \$133,000 to \$150,100 or from \$151.18 to \$171.61 per square foot of living area including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the appellant failed to lay any foundation for the adjustments within the property equalization values grid and therefore the Board will give these adjustments no weight and will look solely to the raw sales data. The Board further questions the credibility of the appellant's Property Tax Analysis given their report appears to have been prepared by Pro Tax Appeal, without any showing of the assessment and/or appraisal qualifications of person(s) who prepared the analysis.

The parties submitted 12 comparable sales for the Board's consideration. The Board gave less weight to the appellant's comparables #6 through #8 and the board of review's comparables #2 through #4 due to their dissimilar basement type when compared to the subject property. The Board finds the best evidence of market value in the record to be the appellant's comparables #1 through #5 and the board of review's comparable #1. These comparables are similar in location, age, dwelling size, design and other features. These comparables sold for prices ranging from \$47,000 to \$135,000 or from \$52.63 to \$151.18 per square foot of living area including land. The subject's assessment reflects an estimated market value of \$133,030 or \$147.16 per square foot of living area including land which falls within the range established by the best sales comparables in this record. Based on this record the Board finds the subject's assessment is reflective of market value and a reduction in the subject's assessment is not justified.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
