



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: SRP SUB, LLC

The parties of record before the Property Tax Appeal Board are SRP SUB, LLC, the appellant, by attorney Abby L. Strauss, of Schiller Strauss & Lavin PC in Chicago; and the Will County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Will County Board of Review** is warranted. The correct assessed valuation of the property is:

**LAND:** \$14,231  
**IMPR.:** \$23,171  
**TOTAL:** \$37,402

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Will County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property is improved with a raised ranch dwelling of frame exterior construction with 1,440 square feet of living area. The dwelling was constructed in 1967. Features of the home include a concrete slab foundation. The property has a 6,722 square foot site and is located in Romeoville, Lockport Township, Will County.

The appellant contends overvaluation as the basis of the appeal. The appellant's evidence disclosed the subject sold December 19, 2013 for a price of \$81,000 and had been advertised for sale as set forth in Section IV-Recent Sale Data of the appeal petition. To document the sale, the appellant submitted a copy of the Real Estate Contract, the Settlement Statement revealing the amount of Broker's Fees paid at settlement, the PTAX-203, Illinois Real Estate Transfer Declaration which disclosed the property had been advertised for sale and the Multiple Listing

Service sheet. Based on this evidence, the appellant requested the total assessment be reduced to \$27,000.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$37,402. The subject's assessment reflects a market value of \$112,487 or \$78.12 per square foot of living area, when applying Will County's 2015 three-year average median level of assessment of 33.25% as determined by the Illinois Department of Revenue. 86 Ill.Admin.Code §1910.50(c)(1).

In support of its contention of the correct assessment the board of review submitted information on four comparable sales that were built from 1969 to 1971. The comparables had varying degrees of similarity when compared to the subject. The comparables were improved with raised ranch dwellings that each contain 1,440 square feet of living area. The comparables sold from September 2013 to July 2014 for prices ranging from \$120,000 to \$149,900 or from \$83.33 to \$104.10 per square foot of living area, including land. The board of review's submission also include the PTAX-203, Illinois Real Estate Transfer Declaration for the subject property and the comparables. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted the subject's sale and four suggested sales for the Board's consideration. The Board gave less weight to the subject's sale and the board of review comparables #3 and #4 due to their 2013 sale dates, less proximate in time for the assessment date of January 1, 2015. The Board finds the best evidence of market value in the record to be the board of review comparables #1 and #2. These properties sold February 2014 and July 2014 for prices of \$145,000 and \$149,900 or \$100.69 and \$104.10 per square foot of living area, including land, respectively. The subject's assessment reflects a market value of \$112,487 or \$78.12 per square foot of living area, including land, which falls below the best comparable sales in this record. Based on this evidence the Board finds the subject's assessment is reflective of the property's market value and a reduction in the assessment is not justified.
