

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are William Clarke, the appellant, by attorney Gregory Riggs of Tax Appeals Lake County, in Lake Zurich; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 32,469 **IMPR.:** \$101,070 **TOTAL:** \$133,539

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of two-story dwelling of wood siding exterior construction that has 2,666 square feet of living area. The dwelling was built in 1979. Features include a partially finished basement, central air conditioning, a fireplace and a 462 square foot attached garage. The subject property is located in Cuba Township, Lake County, Illinois.

The appellant contends assessment inequity as the basis of the appeal. The subject's land assessment was not contested. In support of the inequity claim, the appellant submitted three assessment comparables located in the subject's neighborhood. The comparables had varying degrees of similarity when compared to the subject. The comparables have improvement assessments ranging from \$87,805 to \$91,897 or from \$34.55 to \$36.16 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's final assessment of \$133,539. The subject property has an improvement assessment of \$101,070 or \$37.91 per square foot of living area.

In support of its assessment, the board of review submitted three assessment comparables located in the subject's neighborhood. The comparables had varying degrees of similarity when compared to the subject. The comparables have improvement assessments ranging from \$93,329 to \$108,906 or from \$35.38 to \$40.11 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer argued assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof.

The parties presented six assessment comparables for the Board's consideration. The Board gave less weight to comparable #3 submitted by the appellant because it lacks a garage, inferior to the subject. The Board finds the remaining five comparables are more similar when compared to the subject in location, design, age, dwelling size and most features. They have improvement assessments ranging from \$87,805 to \$108,906 or from \$35.91 to \$40.11 per square foot of living area. The subject property has an improvement assessment of \$101,070 or \$37.91 per square foot of living area, which falls within the range established by the most similar comparables in the record. The Board finds comparable #3 submitted by the board of review was most similar comparable to the subject due to the fact it had a partial finished basement like the subject. It had an improvement assessment of \$108,906 or \$40.11 per square foot of living area. After considering any necessary adjustments to the comparables for any differences when compared to the subject, the Board finds the subject's improvement assessment is supported and no reduction in warranted.

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
