

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Lisa Lendvay DOCKET NO.: 15-02835.001-R-1 PARCEL NO.: 13-02-402-002

The parties of record before the Property Tax Appeal Board are Lisa Lendvay, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$40,239 **IMPR.:** \$114,184 **TOTAL:** \$154,423

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of wood exterior construction with 1,974 square feet of living area. The dwelling was constructed in 1988. Features of the home include a finished basement, central air conditioning, a fireplace and a 658 square foot attached garage. The property has a 75,196 square foot site and is located in Barrington, Cuba Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of the overvaluation argument, the appellant submitted four comparable sales located within 1.08 miles from the subject property. The comparables consist of one-story dwellings that were built from 1955 to 1987. The dwellings had features with varying degrees of similarity when compared to the subject. The dwellings range in size from 1,960 to 2,442 square feet of living area and are situated on sites that contain from 34,317 to 78,007 square feet of land area. The comparables

sold from January 2014 to June 2015 for prices ranging from \$293,000 to \$499,000 or from \$119.98 to \$220.41 per square foot of living area including land. Based on this evidence, the appellant requested the total assessment be reduced to \$138,166 which would reflect a market value of approximately \$414,498.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's final assessment of \$154,423. The subject's assessment reflects an estimated market value of \$465,410 or \$235.77 per square foot of living area including land when applying Lake County's 2015 three-year average median level of assessment of 33.18% as determined by the Illinois Department of Revenue. 86 Ill.Admin.Code §1910.50(c)(1).

In support of the subject's assessment, the board of review submitted information on three comparable sales located within 1.08 miles from the subject property. The comparables consist of one-story dwellings that were built from 1956 to 1987. The dwellings had features with varying degrees of similarity when compared to the subject. The dwellings range in size from 2,021 to 2,264 square feet of living area and are situated on sites that contain from 34,317 to 74,676 square feet of land area. The comparables sold from January to October 2014 for prices ranging from \$499,000 to \$543,500 or from \$220.41 to \$268.93 per square foot of living area including land. Board of review sale #1 was the same comparable as the appellant's sale #4. The board of review submission included property record cards for the subject and its three comparable sales. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted six suggested sales for the Board's consideration with one comparable common to both parties. The Board gave less weight to the appellant's comparable #1 due to its larger dwelling size and lack of a basement when compared to the subject property.

The Board finds the best evidence of market value in the record to be the appellant's comparables #2 through #4 and the board of review's comparables. These comparables sold proximate in time to the January 1, 2015 assessment date and were similar to the subject in location, age, dwelling size, design and other features. These properties sold from January 2014 to June 2015 for prices ranging from \$361,000 to \$543,500 or from \$174.60 to \$268.93 per square foot of living area including land. The subject's assessment reflects a market value of \$468,424 or \$237.30 per square foot of living area, including land, which falls within the range established by the best comparables in this record. Based on this evidence the Board finds the subject is not overvalued and a reduction in the assessment is not justified.

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
