



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Barbara Moore

The parties of record before the Property Tax Appeal Board are Barbara Moore, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds No Change in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$43,303
IMPR.: \$227,766
TOTAL: \$271,069

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of wood siding exterior construction with 5,502 square feet of living area. The dwelling was constructed in 1994. Features of the home include a basement with finished area, central air conditioning, three fireplaces and an 816 square foot garage. The subject has an 800 square foot in-ground swimming pool. The property has a 56,260 square foot site and is located in Lake Barrington, Cuba Township, Lake County.

The appellant contends assessment inequity as the basis of the appeal. The subject's land assessment was not contested. In support of this argument the appellant submitted information on three equity comparables located from .11 of a mile to 1.2 miles from the subject property. The comparables were improved with two-story dwellings with wood siding exterior construction that ranged in size from 4,781 to 4,874 square feet of living area. The dwellings were constructed in either 1988 or 1993. Features had varying degrees of similarity when

compared to the subject. The comparables had improvement assessments that ranged from \$171,212 to \$188,413 or from \$35.81 to \$38.66 per square foot of living area. Based on this evidence, the appellant requested that the improvement assessment be reduced to \$203,097 or \$36.91 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$271,069. The subject property has an improvement assessment of \$227,766 or \$41.40 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on eight equity comparables located from .31 to 1.33 miles from the subject property. The comparables were improved with two-story dwellings of brick exterior construction that range in size from 5,034 to 5,568 square feet of living area. The dwellings were constructed from 1990 to 1998. Features had varying degrees of similarity when compared to the subject. The comparables had improvement assessments that ranged from \$215,029 to \$255,042 or from \$40.57 to \$45.80 per square foot of living area. The board of review requested that the assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted 11 suggested comparables for the Board's consideration. The Board gave less weight to the appellant's comparables along with the board of review comparables #4 and #7 due to smaller dwelling size when compared to the subject. The board gave less weight to the board of review's comparables #3 and #6 due to their lack of finished basement when compared to the subject's finished basement.

The Board finds the best evidence of assessment equity to be the remaining four board of review comparables. These comparables are more similar in location, style, age, dwelling size and features when compared to the subject property. These comparables had improvement assessments that ranged from \$218,327 to \$255,042 or from \$41.15 to \$45.80 per square foot of living area. The subject's improvement assessment of \$227,766 or \$41.40 per square foot of living area falls within the range established by the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(b) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(b)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
