

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Donna Sowa DOCKET NO.: 15-03144.001-R-1 PARCEL NO.: 09-26-204-135

The parties of record before the Property Tax Appeal Board are Donna Sowa, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$3,272 **IMPR.:** \$21,638 **TOTAL:** \$24,910

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a single-level condominium with 1,149 square feet of living area. The dwelling was constructed in 1974. Features of the condominium include central air conditioning and a fireplace. The property is located in Wauconda, Wauconda Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of the overvaluation argument, the appellant submitted three comparable sales located within .06 of a mile from the subject property. The comparables consist of single-level condominiums that were built in 1974. The dwellings had features with varying degrees of similarity when compared to the subject. The dwellings contain 1,149 or 1,216 square feet of living area. The comparables sold from June 2014 to March 2015 for prices ranging from \$61,000 to \$75,000 or from \$53.09 to \$61.68 per square foot of living area including land. Based on this evidence, the appellant requested the

total assessment be reduced to \$21,446 which would reflect a market value of approximately \$64,338.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's final assessment of \$24,910. The subject's assessment reflects an estimated market value of \$75,075 or \$65.34 per square foot of living area including land when applying Lake County's 2015 three-year average median level of assessment of 33.18% as determined by the Illinois Department of Revenue. 86 Ill.Admin.Code \$1910.50(c)(1).

In support of the subject's assessment, the board of review submitted information on four comparable sales located within .05 of a mile from the subject property. The comparables consist of single-level condominiums that were built in 1974. The dwellings had features with varying degrees of similarity when compared to the subject. The dwellings each contain 1,149 square feet of living area. Comparables #1 through #3 sold from January 2013 to July 2014 for prices ranging from \$76,000 to \$114,000 or from \$66.14 to \$99.22 per square foot of living area including land. Comparable #4 was listed in July of 2016 for a price of \$123,900 or \$107.83 per square foot of living area including land. The board of review submission included property record cards and Multiple Listing Service sheets (MLS) for the subject and its four comparable sales. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted six suggested sales and one active listing for the Board's consideration. The Board gave less weight to the board of review's comparables #2 and #3 due to their 2013 sale dates, which are less proximate in time for the January 1, 2015 assessment date. The Board also gave less weight to the board of review's comparable #4 due to its July 2016 list date, which is 18 months after the January 1, 2015 assessment date.

The Board finds the best evidence of market value in the record to be the appellant's comparables and the board of review's comparable #1. These comparables sold more proximate in time to the assessment date and were similar to the subject in location, age, dwelling size, design and features. These properties sold from June 2014 to March 2015 for prices ranging from \$61,000 to \$85,000 or from \$53.09 to \$73.98 per square foot of living area including land. The subject's assessment reflects a market value of \$75,075 or \$65.34 per square foot of living area, including land, which falls within the range established by the best comparables in this record. Based on

this evidence the Board finds the subject is not overvalued and a reduction in the assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(b) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(b)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
