

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Manjeet Batth, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$54,110 **IMPR.:** \$143,417 **TOTAL:** \$197,527

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property is improved with a part one-story and part two-story dwelling of brick exterior construction with 4,157 square feet of living area. The dwelling was constructed in 2002. Features of the home include a partial unfinished basement, central air conditioning, a fireplace and a 598 square foot garage. The property has a 13,141 square foot site and is located in Woodridge, Lisle Township, DuPage County.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on three equity comparables located within .23 of a mile from the subject property. The comparables are improved with two-story or part one-story and part two-story dwellings of frame exterior construction that were constructed in 2007. These comparables had varying degrees of similarity when compared to the subject. The dwellings range in size from 3,858 to 4,223 square feet of living area and have improvement

assessments ranging from \$119,640 to \$124,500 or from \$28.93 to \$31.01 per square foot of living area. Based on this evidence, the appellant requested the total assessment be reduced to \$178,016.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$217,460. The subject property has an improvement assessment of \$163,350 or \$39.30 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on three equity comparables located within .12 of a mile from the subject property. The comparables are improved with part one-story and part two-story dwellings of frame, brick or frame and brick exterior construction that were constructed from 1996 to 2003. The comparables had varying degrees of similarity when compared to the subject. The dwellings range in size from 3,094 to 3,785 square feet of living area and have improvement assessments ranging from \$123,290 to \$144,750 or \$37.99 to \$41.64 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

#### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted information on a total of six suggested equity comparables for the Board's consideration. The Board gave less weight to the board of review's comparables #1 and #3 due to their smaller dwelling size when compared to the subject property. The Board finds the appellant's comparables and the board of review's comparable #2 are similar when compared to the subject in location, age, dwelling size, design and features. These comparables had improvement assessments that ranged from \$28.93 to \$37.99 per square foot of living area. The subject's improvement assessment of \$39.30 per square foot of living area falls above the range established by the best comparables in this record. Based on this record the Board finds the appellant did demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is justified.

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
