

## FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Mega Properties, Inc. DOCKET NO.: 15-05534.001-C-2 PARCEL NO.: 11-31-105-013

The parties of record before the Property Tax Appeal Board are Mega Properties, Inc., the appellant, by attorney Ryan Sullivan of Kozonis and Associates, Ltd., in Chicago; the Lake County Board of Review; and Diamond Lake S.D. #76, the intervenor, by attorney Jessica Walker of Hodges Loizzi Eisenhammer Rodick & Kohn, in Arlington Heights.

Prior to the hearing, the appellant and the board of review reached an agreement as to the correct assessment of the subject property. The evidence in this record also shows Diamond Lake S.D. #76 adopted the evidence submitted by Lake County Board of Review. Pursuant to Section 1910.99(a) of the rules of the Property Tax Appeal Board, since Diamond Lake S.D. #76 adopted the evidence of the board of review, it is bound by the terms of the stipulation or agreement. (86 Ill.Admin.Code §1910.99(a)).

After reviewing the record and considering the evidence submitted, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this **Lake** County appeal. The Property Tax Appeal Board further finds that the agreement of the parties is proper, and the correct assessed valuation of the property is:

**LAND:** \$376,541 **IMPR.:** \$582,892 **TOTAL:** \$959,433

Subject only to the State multiplier as applicable.

considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
