

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Todd Molis & Kim Asturrizaga

The parties of record before the Property Tax Appeal Board are Todd Molis & Kim Asturrizaga, the appellants, by attorney Katherine Amari O'Dell, of Amari & Locallo in Chicago; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$31,640 **IMPR.:** \$44,290 **TOTAL:** \$75,930

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is improved with a multi-level dwelling of frame exterior construction with 1,140 square feet of living area. The dwelling was constructed in 1971. Features of the home include a partial finished basement, central air conditioning and a 440 square foot garage. The property has a 6,204 square foot site and is located in Willowbrook, Downers Grove Township, DuPage County.

The appellants contend assessment inequity as the basis of the appeal. In support of this argument the appellants submitted information on three equity comparables located within four blocks from the subject property. The comparables are improved with multi-level dwellings of frame exterior construction that range in age from 42 to 48 years old. The comparables had features with varying degrees of similarity when compared to the subject. The dwellings contain 1,140 or 1,144 square feet of living area and have improvement assessments ranging from

\$38,180 to \$39,050 or from \$33.37 to \$34.25 per square foot of living area. Based on this evidence, the appellants requested the total assessment be reduced to \$70,104.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$75,930. The subject property has an improvement assessment of \$44,290 or \$38.85 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on three equity comparables located in the same neighborhood as the subject property. The comparables are improved with multi-level dwellings of frame exterior construction that were constructed in 1976 or 1985. The comparables had features with varying degrees of similarity when compared to the subject. The dwellings contain 1,080 or 1,194 square feet of living area and have improvement assessments ranging from \$42,160 to \$47,760 or from \$39.04 to \$40.00 per square foot of living area. Based on this evidence, the board of review requested confirmation

Conclusion of Law

The taxpayers contend assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted information on a total of six suggested equity comparables for the Board's consideration. The Board gave less weight to the board of review's comparables #1 and #2 due to their newer age when compared to the subject property. The Board finds the appellant's comparables and the board of review's comparable #3 are similar when compared to the subject in location, age, dwelling size, design, exterior construction and features. These comparables had improvement assessments that ranged from \$33.37 to \$39.04 per square foot of living area. The subject's improvement assessment of \$38.85 per square foot of living area falls within the range established by the best comparables in this record. Based on this record the Board finds the appellants did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
