

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Danile Goodrich, the appellant, by attorney John S. Xydakis, of the Law Offices of John S. Xydakis in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$4,650 IMPR.: \$32,176 TOTAL: \$36,826

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of masonry construction. The dwelling is approximately 65 years old and has 2,011 square feet of living area. Features of the home include a full finished basement, central air conditioning, a fireplace and a one-car garage. The property has a 6,200-square foot site and is located in Park Ridge, Maine Township, Cook County. The subject is classified as a class 2-05 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on three equity comparables with the same assigned neighborhood and classification codes as the subject. The comparables are improved with two-story dwellings of masonry or frame and masonry construction. The dwellings are from 69 to 114 years old and contain from 1,707 to 1,918 square feet of living area. The comparables have unfinished basements; one comparable has central air conditioning; and

another has a fireplace. Information regarding garages was not provided on the appellant's grid analysis. The comparables have improvement assessments ranging from \$3,337 to \$28,022 or from \$1.95 to \$14.61 per square foot of living area. The appellant also submitted a map showing the location of the subject property and the comparable properties. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$26,807 or \$13.33 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$36,826 was disclosed. The subject property has an improvement assessment of \$32,176 or \$16.00 per square foot of living area. The board of review presented descriptions and assessment information on four suggested comparable properties with the same assigned neighborhood and classification codes as the subject. One of the comparables is located in the same block as the subject, and the other three were described as being located one-quarter mile the subject property. The comparables are improved with two-story dwellings of masonry construction. The dwellings are from 63 to 73 years old and contain from 1,575 to 2,053 square feet of living area. Three comparables have full unfinished basements, and one has a partial finished basement. The comparables have central air conditioning, one or two fireplaces, and garages that range from one-car to three-car. These properties have improvement assessments ranging from \$29,862 to \$38,792 or from \$18.90 to \$19.37 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties presented assessment data on a total of seven suggested comparables. The Board gave less weight to four of the seven comparables: The appellant's comparables #2 and #3 were significantly older than the subject; the appellant's comparable #1 was found to be an outlier with an improvement assessment of \$1.95 per square foot of living area that was substantially lower than any other comparable; and board of review comparable #2 had significantly less living area than the subject. The Board finds the best evidence of assessment equity to be board of review comparables #1, #3 and #4. The Board finds these comparables were very similar to the subject in location, story height, age, living area and age. Moreover, board of review comparable #4 was most similar to the subject in living area and was the only dwelling to have basement finished area like the subject. Board of review comparables #1, #3 and #4 had improvement assessments that ranged from \$18.90 to \$19.37 per square foot of living area. The subject's improvement assessment of \$16.00 per square foot of living area falls below the range established by the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
