

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Jackie & Eddie Greer DOCKET NO.: 15-28258.001-R-1 PARCEL NO.: 25-22-112-039-0000

The parties of record before the Property Tax Appeal Board are Jackie & Eddie Greer, the appellant(s); and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$3,465 **IMPR.:** \$2,055 **TOTAL:** \$5,520

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of masonry construction with 2,760 square feet of living area. The dwelling is 122 years old. The property has a 5,775 square foot site and is located in Hyde Park Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellants contend overvaluation as the basis of the appeal. In support of this argument, the appellants submitted information on five suggested comparable sales and adjustment information. The appellants requested a total assessment reduction to \$2,654.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$25,661. The subject's assessment reflects a market value of \$256,610, or \$92.97 per square foot of living area including land, when applying the level of assessment of 10.00% for Class 2 property under the Cook County Real Property Assessment

Classification Ordinance. In support of its contention of the correct assessment, the board of review submitted information on four suggested sales comparables that sold for prices ranging from \$103.64 to \$143.82 per square foot of living area including land.

In rebuttal, the appellants distinguished the board's comparables from the subject property.

Conclusion of Law

The appellants contend the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellants did meet this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the appellants failed to lay a foundation for the adjustments in the equalization value grid submitted and, therefore, gives the adjustments no weight.

The Board further finds the best evidence of market value to be the appellants' comparable sales #1, #4 and #5. These comparables sold for prices ranging from \$4.00 to \$20.73 per square foot of living area, including land. The subject's assessment reflects a market value of \$92.97 per square foot of living area including land, which is above the range established by the best comparable sales in this record. Based on this evidence, and after making adjustmentsthe Board finds a reduction in the subject's assessment is justified.

the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
