

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANTS: Brad & Karen Martin DOCKET NO.: 15-28902.001-R-1 PARCEL NO.: 04-20-412-023-0000

The parties of record before the Property Tax Appeal Board are Brad & Karen Martin, the appellants, by attorney Timothy E. Moran, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$8,382 **IMPR.:** \$39,044 **TOTAL:** \$47,426

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellants timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of frame and masonry exterior construction with 2,873 square feet of living area. The dwelling is approximately 26 years old. Features of the home include a full unfinished basement, central air conditioning, a fireplace and a two-car garage. The property has a 10,160 square foot site and is located in Glenview, Northfield Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellants contend assessment inequity as the basis of the appeal. The subject's land assessment was not contested. In support of this argument the appellants submitted information on five equity comparables located within the same neighborhood code as the subject property. The comparables were improved with two-story dwellings of masonry or frame and masonry exterior construction that ranged in size from 2,726 to 2,862 square feet of living area. The

dwellings are from 26 to 36 years old. Four comparables have partial or full unfinished basements and central air conditioning. Four comparables have a two-car garage. The comparables had improvement assessments that ranged from \$30,835 to \$31,958 or from \$10.99 to \$11.60 per square foot of living area. Based on this evidence, the appellants requested that the improvement assessment be reduced to \$31,890 or \$11.10 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$47,426. The subject property has an improvement assessment of \$39,044 or \$13.59 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on three equity comparables located within the same neighborhood code, block and street as the subject property. The comparables were improved with two-story dwellings of frame and masonry exterior construction that contained either 2,873 or 3,282 square feet of living area. Each dwelling is 26 years old and has a full unfinished basement, central air conditioning, a fireplace and a 2-car or a 2.5-car garage. The comparables had improvement assessments that ranged from \$40,251 to \$48,738 or from \$14.01 to \$15.11 per square foot of living area. Based on this evidence, the board of review requested that the assessment be confirmed.

## **Conclusion of Law**

The taxpayers contend assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board gave greater weight and finds the best evidence of assessment equity to be the board of review comparables which are located within the same neighborhood code, block and street as the subject property. These comparables are identical to the subject in design, exterior construction, age, foundation and most features. Two of these comparables are also identical to the subject's dwelling size. These comparables had improvement assessments that ranged from \$40,251 to \$48,738 or from \$14.01 to \$15.11 per square foot of living area. The subject's improvement assessment of \$39,044 or \$13.59 per square of living area is slightly below the best comparables contained in this record and appears to be under assessed when compared to these comparables. However, the board of review did not request an increase in the subject's assessment. The Board gave less weight to the appellants' comparables due to their differences in location, age, foundation and/or features when compared to the subject property. Based on this record the Board finds the appellants did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
