



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: South Coast Holdings

The parties of record before the Property Tax Appeal Board are South Coast Holdings, the appellant(s), by attorney Stephanie Park, of Park & Longstreet, P.C. in Rolling Meadows; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$1,937
IMPR.: \$10,868
TOTAL: \$12,805

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is a 107 year-old, two-story dwelling of masonry construction containing 1,976 square feet of living area. The property has a 3,875 square foot site in Chicago, Lake Township, Cook County. The property is a Class 2 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant's appeal is based on overvaluation based on a recent sale of the subject and on sale comparable properties. In support of the recent sale overvaluation argument, the appellant submitted a settlement statement disclosing the subject property was purchased by South Coast Holdings ("South Coast") from Federal National Mortgage Association ("Fannie Mae") on July 6, 2012 for \$28,000 in an all-cash transaction. The subject's sale price reflects a market value of

\$14.17 per square foot of living area including land. The appellant also submitted an affidavit of Jon Bowers (“Bowers”), an agent for South Coast attesting that South Coast purchased the subject from Fannie Mae for \$28,000 in an arm’s-length transaction on July 6, 2012. Bowers also attested that the “property was not purchased in settlement of an installment contract, a contract for deed, or a foreclosure...” Bowers did not disclose in his affidavit how the transaction was settled. However, the appellant included information in Section IV–Recent Sale Data of the Residential Appeal that the subject was not sold as a transfer between related parties; was advertised and sold through a realtor; and was sold in settlement of a contract for deed.

In support of the sales market comparable argument of overvaluation, the appellant submitted information on four suggested comparable sales that sold from February 2012 through July 2014 for prices ranging from \$6.80 to \$11.72 per square foot of living area including land.

The appellant requested a reduction in the subject's assessment to \$1,340.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$12,805. The subject's assessment reflects a market value of \$128,050, or \$64,80 per square foot of living area, when using the 2015 level of assessment of 10.00% for Class 2 property under the Cook County Real Property Assessment Classification Ordinance. In support of its contention of the correct assessment, the board of review submitted information on four suggested comparable sales that sold from September 2014 through December 2014 for prices ranging from \$67.53 to \$110.12 per square foot of living area including land.

The board of review also submitted a brief in which it argued the subject’s sale was compulsory because it was not at arm’s-length for fair cash value. The board of review appended a deed trail to the brief, disclosing the following documents were recorded: a *lis pendens* and Notice of Foreclosure in 2009; a Judicial Sales Deed granted to Fannie Mae in 2012; and a Special Warranty Deed from Fannie Mae to South Coast in 2012.

In rebuttal, the appellant reiterated its argument that the sale was at arm’s-length for fair cash value. The appellant included many other sub-arguments that did not address the issues raised. The appellant reaffirmed the request for an assessment reduction.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant has not met this burden of proof and a reduction in the subject's assessment is not warranted.

The Board accords minimal weight to the affidavit of Bowers. He attested that South Coast purchased the subject property in an arm's-length transaction without evidence establishing his qualifications to render the legal conclusion that it was at arm's-length. Bowers also attested that the subject was not purchased in settlement of an installment contract, contract for deed, or a foreclosure. Yet, the appellant included relevant information in Section IV—Recent Sale Data of the Residential Appeal that the subject was sold in settlement of a contract for deed, in contradiction of Bowers' affidavit. The appellant failed to explain exactly what alternative methods existed to settle the transaction.

In addressing the appellant's market value argument, the Board finds that the sale of the subject from Fannie Mae in July 2012 for \$28,000 is a "compulsory sale." A "compulsory sale" is defined as:

- (i) the sale of real estate for less than the amount owed to the mortgage lender or mortgagor, if the lender or mortgagor has agreed to the sale, commonly referred to as a "short sale" and (ii) the first sale of real estate owned by a financial institution as a result of a judgment of foreclosure, transfer pursuant to a deed in lieu of foreclosure, or consent judgment, occurring after the foreclosure proceeding is complete.

35 ILCS 200/1-23.

Real property in Illinois must be assessed at its fair cash value, which can only be estimated absent any compulsion on either party.

Illinois law requires that all real property be valued at its fair cash value, estimated at the price it would bring at a fair voluntary sale where the owner is ready, willing, and able to sell but not compelled to do so, and the buyer is likewise ready, willing, and able to buy, but is not forced to do so.

Bd. of Educ. of Meridian Cmty. Unit Sch. Dist. No. 223 v. Ill. Prop. Tax Appeal Bd., 961 N.E. 2d 794, 802 (2d Dist. 2011) (citing Chrysler Corp. v. Ill. Prop. Tax Appeal Bd., 69 Ill. App. 3d 207, 211 (2d Dist. 1979)).

The Board may consider market value evidence, such as sales of comparable properties submitted by the parties, to determine whether the subject was sold at fair cash value. 86 Ill.Admin.Code §1910.65(c)(4); *See Calumet Transfer LLC v. Illinois Property Tax Appeal Board*, 401 Ill.App.3d 652 (1st Dist. 2010).

The Board finds the best evidence of market value to be the appellant's comparable sale(s) #3, and the board of review comparable sale(s) #1 and #2. These comparables sold for prices ranging from \$10.97 to \$110.12 per square foot of living area, including land. The subject's assessment reflects a market value of \$64.80 per square foot of living area including land, which is within the range established by the best comparable sales in this record. Based on this evidence, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
