



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Sam Theofanopoulos, the appellant(s), by attorney Jessica Hill-Magiera, Attorney at Law in Lake Zurich; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$1,431  
**IMPR.:** \$3,121  
**TOTAL:** \$4,552

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2015 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property is a 96 year-old, two-story multi-family dwelling of masonry construction containing 2,168 square feet of living area. The property has a 6,364 square foot site in Thornton Township, Cook County. It is a Class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on five suggested comparable sales and adjustment information in a grid entitled, "Property Equalization Values." The appellant requested a total assessment reduction to \$2,690.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$9,050. The subject's assessment reflects a market value of \$90,500 or \$41.74 per square foot of living area including land, when applying the 2015 level of

assessment of 10.00% for Class 2 property under the Cook County Real Property Assessment Classification Ordinance. In support of its contention of the correct assessment, the board of review submitted information on three suggested sale comparables. In addition, the board of review submitted a brief stating that due to appellant's adjustments to sale comparables and opinion of value, and the Order by the Illinois Department of Financial and Professional Regulation fining appellant for such action, the appellant's evidence should be dismissed.

In rebuttal, the appellant distinguished the board of review's comparables based on sale date, age, size, and location. The appellant reaffirmed the request for an assessment reduction and reiterated the argument that appellant's sale comparables were the best evidence of the subject's market value. Lastly, the appellant states that it is not in the Board's purview to enforce an Order by the Illinois Department of Financial and Professional Regulation and that the Board has previously addressed this issue by allowing the raw sales data into evidence.

At hearing, the board of review objected to the appellant's "Property Equalization Values" grid on the grounds that it was inadmissible hearsay evidence without the person who prepared that grid present at hearing and subject to cross-examination under oath. In response, the appellant's attorney agreed to withdraw the "Property Equalization values" grid evidence. The Board allowed appellant's withdrawal of the "Property Equalization Values" grid but held that it may consider the appellant's raw, unadjusted sale data. Lastly, the board of review, with no objection from the appellant, withdrew its brief and exhibits submitted in their Notes on Appeal.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of market value to be the appellant's comparables and the board of review's comparable #1. These comparables are similar in size, age, location, and sale date. These comparables sold for prices ranging from \$2.32 to \$21.07 per square foot of living area, including land. The subject's assessment reflects a market value of \$41.74 per square foot of living area including land, which is above the range established by the best comparable sales in this record. Based on this evidence, the Board finds a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
