



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: American Homes 4 Rent (AH4R)  
DOCKET NO.: 16-00165.001-R-1

The parties of record before the Property Tax Appeal Board are American Homes 4 Rent (AH4R), the appellant, by attorney Michael R. Davies of the Law Offices of Michael R. Davies, Ltd., in Oak Lawn; and the Boone County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Boone** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$ 8,333  
**IMPR.:** \$33,457  
**TOTAL:** \$41,790

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Boone County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a two-story dwelling containing 1,990 square feet of living area that was built in 2001. The subject was reported to have three bedrooms and two bathrooms. Neither party disclosed the subject's exterior construction, foundation type or features such as central air conditioning, fireplaces or a garage. The subject has a 10,001 square foot site. The subject property is located in Bonus Township, Boone County, Illinois.

The appellant submitted evidence before the Property Tax Appeal Board claiming overvaluation as the basis of the appeal. In support of the overvaluation claim, the appellant submitted limited descriptive information for 11 comparable properties that were located from .12 to .73 of a mile from the subject.<sup>1</sup> These comparables were reported to consist of one-story or two-story

dwellings that were built from 1900 to 2005. The dwellings range in size from 1,833 to 2,212 square feet of living area have sites that range in size from 8,712 to 16,178 square feet of land area. The comparables have three or four bedrooms and one to three bathrooms. The appellant failed to disclose the comparables' exterior construction or other salient features. The comparables sold from January 2013 to November 2015 for prices ranging from \$75,750 to \$133,100 or from \$41.03 to \$70.19 per square foot of living area including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$44,778. The subject's assessment reflects an estimated market value of \$133,466 or \$67.07 per square foot of living area including land when applying the 2016 three-year average median level of assessment for Boone County of 33.55%.

In support of the subject's assessment, the board of review submitted a recommendation from the multi-township assessor, Kathi Hendrickson. The assessor argued the appellant supplied two-story homes outside the range we used. "We used 1400-2000 SQ FT for the subject. If you include the appellants 3 valid sales with our 4 comps, the median is still \$133,000." The board of review did not submit any comparable sales for the Board's consideration. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the only evidence of market value contained in this record are the 11 comparable sales submitted by the appellant. The Board finds this evidence is poor due to lack of descriptive information. Nonetheless, the Board shall make a decision as to the correct assessment of the subject property regardless of the quality of the evidence. The Board gave less weight to comparables #1, #5, #7, #9, #10 and #11 submitted by the appellant. These comparables sold in 2013, which are dated and less reliable indicators of market value in relation to the subject's January 1, 2016 assessment date. The Board also gave less weight to comparables #6, #7 and #9 due to their older age when compared to the subject. Based on the limited descriptive data submitted, the Board finds the remaining four comparable sales are more similar when compared to the subject in location, age, dwelling size and features. They sold from February 2014 to November 2015 for prices ranging from \$125,500 to \$133,100 or from \$54.95 to \$62.20 per square foot of living area including land. The subject's assessment reflects an estimated market value of \$133,466 or \$67.07 per square foot of living area including land, which falls above the range established by the most similar comparable sales contained in the record. Based on this limited record, the Board finds the subject's estimated market value as reflected by its assessment is excessive. Therefore, a reduction in the subject's assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
