

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are American Homes 4 Rent Pro, the appellant, by attorney Michael R. Davies of the Law Offices of Michael R. Davies, Ltd. in Oak Lawn; and the Will County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the **Will** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$14,904
IMPR.:	\$56,279
TOTAL:	\$71,183

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Will County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

### **Findings of Fact**

The subject property consists of a part two-story and part one-story dwelling of frame exterior construction with 2,194 square feet of living area.<sup>1</sup> The dwelling was constructed in 2002. Features of the home include a full basement, central air conditioning and a 441 square foot garage. The property has a 9,215 square foot site<sup>2</sup> and is located in Plainfield, Plainfield Township, Will County.

The appellant submitted evidence before the Property Tax Appeal Board claiming overvaluation as the basis of the appeal. In support of the overvaluation claim, the appellant submitted limited

descriptive information for four comparable properties. The Board requested that the appellant complete the grid analysis in Section V of the appeal petition. The appellant failed to comply with the Board's request and failed to disclose the comparables' proximity to the subject, design, exterior construction and foundation type. Two comparables were described as consisting of two-story dwellings. The appellant did not disclose the design of the two remaining comparables. The dwellings were built in 2002 or 2003 and range in size from 1,943 to 2,470 square feet of living area. The comparables have central air conditioning and one comparable has a fireplace. The comparables sold from March 2016 to May 2016 for prices ranging from \$198,000 to \$252,500 or from \$98.79 to \$105.25 per square foot of living area, land included. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$71,183. The subject's assessment reflects a market value of \$214,020 or \$97.55 per square foot of living area, land included, when using the 2016 three-year average median level of assessment for Will County of 33.26% as determined by the Illinois Department of Revenue.

The board of review submitted a letter from the Plainfield Township Assessor's Office along with additional data. The assessor disclosed the subject is assessed below its July 2014 sale price of \$219,000 or \$99.82 per square foot of living area, including land. The assessor asserts the subject's assessment is below all comparables submitted by both parties.

In support of its contention of the correct assessment, the board of review submitted information on eight comparable sales located within one mile of the subject property, seven of which are located in the same neighborhood as the subject property as defined by the local assessor. The comparables consist of four, two-story and four, part two-story and part one-story dwellings of frame exterior construction built from 2002 to 2005. The dwellings range in size from 2,194 to 2,278 square feet of living area and are situated on sites containing from 7,671 to 10,400 square feet of land area. Each comparable has a basement, central air conditioning and two comparables have a fireplace. The comparables sold from April 2015 to July 2016 for prices ranging from \$222,500 to \$245,000 or from \$100.95 to \$107.55 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and no reduction in the subject's assessment is warranted.

The parties submitted twelve suggested comparable sales for the Board's consideration. The Board gave less weight to the comparables submitted by the appellant since the appellant's attorney failed to provide specifics regarding the comparables locations, design, exterior construction and foundation type for a comparative analysis, which detracts from the weight of the evidence. The Board also gave less weight to board of review comparable #3 due to its location outside of the subject's neighborhood.

The Board finds the best evidence of market value to be the remaining seven comparables submitted by the board of review. These comparables are most similar to the subject in location, size, design, age and features. These comparables sold from April 2015 to July 2016 for prices ranging from \$222,500 to \$245,000 or from \$100.95 to \$107.55 per square foot of living area, including land. The subject's assessment reflects a market value of \$214,020 or \$97.55 per square foot of living area, including land, which falls below the range established by best comparable sales in this record. After considering adjustments to the comparables for differences when compared to the subject, the Board finds the subject's estimated market value as reflected by its assessment is supported. Therefore, no reduction in the subject's assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
