



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: AMH 201 4-2 Borrower LLC A  
DOCKET NO.: 16-00993.001-R-1

The parties of record before the Property Tax Appeal Board are AMH 201 4-2 Borrower LLC A, the appellant, by attorney Michael R. Davies, of Ryan Law LLP, in Chicago, and the Will County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the Will County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$12,450  
**IMPR.:** \$39,150  
**TOTAL:** \$51,600

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Will County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a two-story dwelling of frame construction with 1,320 square feet of living area. The dwelling was constructed in 1999. Features of the home include a full basement, central air conditioning, a fireplace and a 440 square foot garage. The property has a 10,149 square foot site and is located in Joliet, Troy Township, Will County.

The appellant's appeal is based on overvaluation. In support of this argument the appellant submitted limited evidence in Section IV – Recent Sale Data of the Residential Appeal petition disclosing the subject property was purchased in February 2013 from "Sasha Castrejon" for a price of \$140,000. While the appellant was requested to provide additional information to complete the appeal, by letter dated August 10, 2017 by the Property Tax Appeal Board, the appeal was accepted and the board of review was simultaneously, but separately, notified of its

duty to respond to the appeal within 90 days. Based on this limited recent sale evidence, the appellant requested a reduction in the subject's assessment to reflect the 2013 purchase price.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$51,600. The subject's assessment reflects a market value of \$155,141 or \$117.53 per square foot of living area, land included, when using the 2016 three year average median level of assessment for Will County of 33.26% as determined by the Illinois Department of Revenue.

Initially in response to the appeal, the board of review and the township assessor both requested dismissal of the appeal since the appellant failed to comply with the Property Tax Appeal Board's request for additional information.

In support of its contention of the correct assessment, the board of review submitted information on four comparable sales identified by the township assessor improved with two-story dwellings of frame or frame and brick trim construction containing either 1,320 or 1,352 square feet of living area that were located within the subject's neighborhood code as assigned by the assessor. The dwellings were constructed between 1996 and 2004 with features that include either a crawl-space foundation or a full basement, central air conditioning and a 440 square foot garage. These properties sold between March and August 2015 for prices ranging from \$154,900 to \$205,000 or from \$117.35 to \$151.63 per square foot of living area, including land.

The township assessor also contended based on data found on the internet that the subject property "is rented out and generating a monthly income."<sup>1</sup>

Based on the foregoing evidence and argument, the board of review requested an increase in the assessment of the subject property to reflect the median sales price or a new total assessment of \$60,661 which would reflect a market value of \$182,384 or \$138.17 per square foot of living area, including land.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted evidence of the subject's 2013 sale price and four comparable sales to support their respective positions before the Property Tax Appeal Board.

<sup>1</sup> There was no income approach analysis performed to support this assertion. Furthermore, the courts have stated that where there is credible evidence of comparable sales these sales are to be given significant weight as evidence of market value. (Chrysler Corporation v. Property Tax Appeal Board, 69 Ill. App. 3d 207 (2<sup>nd</sup> Dist. 1979))

The Board gave little weight to the subject's February 2013 sale due to the fact the sale did not occur as proximate in time to the assessment date at issue of January 1, 2016 as did the comparable sales in the record. In addition, there was no evidence presented by the appellant that the sale transaction had any of the elements of an arm's length transaction as there was no indication if the property sold between related parties; there was no indication whether the property was advertised or exposed on the open market prior to the sale; and/or there was no evidence whether the transaction occurred between a willing seller and a willing buyer.

The Board has also given reduced weight to board of review comparable #2 which has a full crawl-space foundation as compared to the subject's full basement foundation.

The Board finds the best evidence of market value in the record to be comparable sales #1, #3 and #4 submitted by the board of review. These comparables were similar to the subject in location, style, construction, size, features and/or age. These properties also sold more proximate in time to the assessment date at issue than the February 2013 sale of the subject property. The comparables sold between March and August 2015 for prices ranging from \$154,900 to \$205,000 or from \$117.35 to \$151.63 per square foot of living area, including land. The subject's assessment reflects a market value of \$155,141 or \$117.53 per square foot of living area, including land, which is within the range of the comparable sales both in terms of overall value and on a per-square-foot basis.

As to the board of review request to increase the subject's assessment based upon the median of the four recent sales, the Property Tax Appeal Board finds the subject's current total assessment of \$51,600 is slightly below the total assessment of board of review comparable #1 which is most similar to the subject. Furthermore, the total assessments of the remaining three board of review comparables range from \$49,200 to \$54,200. While the Will County Board of Review has requested an increase in the subject's total assessment to \$60,661 this would place the subject substantially above the similar comparables presented by the board of review.

On this record, the Property Tax Appeal Board finds that the subject is not overvalued and no change in the assessment of the subject property is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
