

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Sandeep Patel DOCKET NO.: 16-02385.001-R-1 PARCEL NO.: 06-36-112-004

The parties of record before the Property Tax Appeal Board are Sandeep Patel, the appellant, by attorney Gregory Riggs of Tax Appeals Lake County in Lake Zurich; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$17,112 **IMPR.:** \$74,061 **TOTAL:** \$91,173

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of vinyl siding exterior construction with 2,711 square feet of living area. The dwelling was constructed in 1998. Features of the home include a full unfinished basement, central air conditioning, a fireplace and a 462 square foot garage. The property has a 7,540 square foot site and is located in Grayslake, Avon Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on three comparable sales located within .11 of a mile of the subject property. The comparables were described as two-story dwellings of vinyl siding exterior construction that were built between 1991 and 1998. The dwellings range in size from 2,602 to 2,760 square feet of living area. Each comparable has a basement, with two having finished area. The comparables each have central air conditioning, a fireplace and a garage

containing either 380 or 462 square feet of building area. The comparables have sites ranging in size from 9,095 to 10,968 square feet of land area. The comparables sold from November 2014 to December 2015 for prices ranging from \$260,000 to \$272,700 or from \$94.20 to \$104.80 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$91,173. The subject's assessment reflects a market value of \$274,949 or \$101.42 per square foot of living area, land included, when using the 2016 three-year average median level of assessment for Lake County of 33.16% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on six comparable sales located within .49 of a mile of the subject property. The comparables were described as two-story dwellings of vinyl siding exterior construction built from 1993 to 2000. The dwellings range in size from 2,411 to 3,072 square feet of living area. The comparables each have a full or partial unfinished basement, central air conditioning, a fireplace and a garage ranging in size from 392 to 630 square feet of building area. The comparables have sites ranging in size from 7,732 to 13,067 square feet of land area. The comparables sold from February 2014 to June 2016 for prices ranging from \$244,000 to \$345,000 or from \$83.66 to \$131.73 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and no reduction in the subject's assessment is warranted.

The parties submitted nine suggested comparables for the Board's consideration. The Board gave less weight to the appellant's comparable #1 and board of review comparables #1, #2, #4 and #6 that sold in 2014 which are dated and less likely to be indicative of the subject's market value as of the January 1, 2016 assessment date.

The Board finds the best evidence of market value to be the appellant's comparables #2 and #3, along with board of review comparables #3 and #5. These four comparables sold more proximate in time to the lien date at issue and are similar to the subject in location, dwelling size, design, age and most features. These comparables sold from January 2015 to June 2016 for prices ranging from \$257,000 to \$320,000 or from \$83.66 to \$123.93 per square foot of living area, including land. The subject's assessment reflects a market value of \$274,949 or \$101.42 per square foot of living area, including land, which falls within the range established by the best comparable sales in this record. After considering adjustments to the comparable sales for differences when compared to the subject, the Board finds no reduction in the subject's estimated market value as reflected by its assessment is justified.

The Property Tax Appeal Board does not require any motion or request for reconsideration.

Date:

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
